<b>Course Description:</b>	This course provides theoretical and clinical knowledge to assist the Registered Practical Nurse (RPN) with transitioning into Sault College's Honours Bachelor of Science in Nursing Program. Emphasis is placed upon integration of prior and new learning as the student prepares for science-based Registered Nursing (RN) practice with individuals, families/groups, communities, and populations. Although building upon all levels of professional communication, skill-building in writing will be highlighted. Students utilize the nursing process for obtaining, analyzing, managing, and documenting health information used to make evidence-informed nursing judgements.
