- 1.7 Outline the legal system in Canada, the role of the government, the legislative process and the Charter of Rights and Freedoms.
- 1.8 Explain the role and function of self-regulating bodies and how they ensure public protection, specifically College of Nurses of Ontario.
- 1.9 Develop an understanding of valid and informed consent, the concept of competence and capacity and the concept of substitute consent.
- 1.10 Outline the relationship of ethical principles and theory to informed consent.
- 1.11 Explain the role of advanced directives and substitute decision making.
- 1.12 Develop an understanding of the nurse's advocacy role and the rights of patients to refuse medical care.
- 1.13 Explain the professional responsibilities and accountabilities of nurses, as well as the ethical, and legal aspects of competence, negligence, misconduct and malpractice.
- 1.14 Explain the legal requirements of proper nursing documentation and its significance under the law. Outline six guidelines for documentation and reporting and the elements to include in your documentation.
- 1.15 Identify purposes of a health record/chart and ways to maintain confidentiality of the patient's record/chart.
- 1.16 Explain what rights and responsibilities patients have and the obligations of the health care professional.
- 1.17 Explain the rights of nurses as citizens, professionals, and employees. Introduction to Ontario Nurse's Association (ONA).
- 1.18 Develop an understanding of the significance of ethical organizations and leaders on nursing practice and patient outcomes and the important ethical issues facing nursing leadership.
- 1.19 Develop an understanding of the importance of patient and family centered care.
- 1.20 Explain responsible, assertive, caring communication, the nurse-patient relationship and communication and culture.
- 1.21 Outline communication techniques and skills including: showing respect, asking questions, how to work together with patients and co-workers, confrontation skills, communicating with difficult patients and co-workers and managing conflict.
