This will require the drawing of a free body diagram of a partial truss that is part of the entire truss.</p> <p>8) Describe what is meant by a three-force member and identify clearly the difference between this type of member and the previously used two-force member.</p> <p>9) Using the method known as the Method of Members determine the forces in members of various mechanisms being certain to identify whether the members are in tension or compression.</p>

The applied force starts at zero and increases gradually up to the point where the block begins to slide. When sliding at a constant velocity, the applied force tends to decrease, and then remain constant.</p> <p>3) Indicate clearly the two distinct regions of the graph drawn above, namely, the static region and the kinetic region.</p> <p>4) Explain what is meant by the coefficient of friction.</p> <p>5) Write the equation for the coefficient of static friction.</p> <p>6) Write the equation for the coefficient of kinetic friction.</p> <p>7) Explain what is meant by the angle of friction.</p>

	<p>8) Write the equation for the angle of friction in terms of the maximum force of static friction and the normal reaction force between the object and the surface upon which it rests.</p> <p>9) Solve a variety of problems involving friction. These problems will include those that require the student to determine whether motion is impending or not. Also, solve those problems that require the student to determine whether tipping or sliding will occur.</p>
