| Course Description:   | This course will equip students with the skills and confidence to effectively and safely manage<br>and prevent challenging behaviour. Participants will learn communication skills to effectively<br>intervene with people who may be anxious, disruptive or demonstrating escalating behaviours.<br>Participant will learn skills to diffuse situations and disengagement skills that attend to care,<br>welfare, safety and security of those involved in crisis situations. Successful completion results<br>in a certificate in Non-Violent Crisis Intervention, through the Crisis Prevention Institute. The<br>course will be scheduled in a one-day workshop format. Participants are required to complete<br>online learning modules in advance of class time and attend all aspects of training to receive a<br>satisfactory grade and be eligible for the certificate and a satisfactory grade.   |  |  |  |
