COURSE DESCRIPTION:

I. This course carries on from the knowledge learned in AVT112, with an emphasis on the practical application of the Dead reckoning navigation.

II. LEARNING OUTCOMES AND ELEMENTS OF THE PERFORMANCE:

Upon successful completion of this course, the student will demonstrate the ability to:

1. use the CR-5 Navigation Flight Computer

Potential Elements of the Performance:

Calculating groundspeeds, TAS, Density altitude, wind correction angles, actual winds in flight, etc

2. apply navigation theory from AVT112

Potential Elements of the Performance:

preparation for cross country flight, navigation logs, aviation charts and publications, executing a cross country flight, controlled and uncontrolled airspace, determining airport services and special procedures

3. understand the use of certain radio navigation aids

Potential Elements of the Performance:

the VOR, GPS, and the Transponder

III. TOPICS:

- 1. the CR-5 flight computer
- 2. Dead reckoning navigation
- Radio navigation aids

IV. REQUIRED RESOURCES/TEXTS/MATERIALS:

From The Ground Up, Flight Training Manual Sault Ste Marie VNC, Toronto VNC, and Toronto VTA Jeppesen CR-5 Navigation Computer Canada Flight Supplement AIP

V. EVALUATION PROCESS/GRADING SYSTEM:

The student will be assessed by a combination of attendance and deportment, quizzes, tests and a final exam. Weighting of each will be as follows: 10% for attendance and deportment, 10% for quizzes, 40 % for all tests prior to the final exam and 40% for the final exam. A minimum mark of 70% is required to pass the course. Make-up tests are not permitted except in accordance with section VI of this outline.

- When attendance is taken, the attendance mark will be awarded as follows: unexcused absences will result in 2% deduction, arriving for class late will result in a 1% deduction, and violations of the dress code will result in a 1% deduction up to a maximum of the attendance grade. In the event of illness, a telephone call must be made prior to the beginning of the class (a voice mail message is acceptable). Examples of dress code violations will include, but not limited to, not shaving, not wearing a tie, etc.
- Quizzes will be given without prior notice.
- If it is necessary to write a make-up exam in order to pass the course, the highest grade achievable will be a "C". (See make-up exam policy in section VI)
- Students may request a deferment of a test for compassionate reasons. Compassionate Grounds for deferment will include but not be limited to death of an immediate family member, personal illness, or recent diagnosis of a serious illness of a family member. Re writes will not be permitted after the fact for compassionate reasons.
- "F" grades in any subject at the end of a semester will result in termination from the Aviation program.
- Attendance is mandatory for all Aviation classes unless approval is granted in advance. In the case of illness, a phone call, voice mail or e-mail message is expected.
- If a student expects to be late or will be delayed for any reason, every attempt should be made to contact the professor, or leave a message on voice mail or e-mail.
- Although attitude, co-operation, etc., are not graded, students may be terminated based on their performance in this area (see section VI).
 These attributes are also considered in the selection of the Air Canada Award and other scholarships.
- Dates of tests will be announced at least 1 week in advance.

VI. SPECIAL NOTES:

Attitude and Conduct

Attitude plays an important role in your ability to exercise good judgement. Although attitude is not being graded, it affects your ability to learn as well as your safety as a student and future as a professional pilot. Students who display a strong tendency towards any of the five hazardous attitudes pose a grave risk to themselves and others. For this reason these students will be counseled and will be put on a behavioural contract. If counseling is ineffective, then the student will be withdrawn from the program.

The five hazardous attitudes are identified as Anti-authority, Impulsivity, Invulnerability, Machismo, and Resignation. These hazardous attitudes are described in "Human Factors for Aviation – Basic Handbook" on pages 151 and 152.

Make-up exam Policy

- No make-up tests allowed on tests occurring prior to final exams.
- If the final grade achieved for this course is less than 70%, a second final exam may be written at the discretion of the professor for this course. The second exam will be averaged with the first exam to determine the resulting exam mark, and the final grade will be then calculated.
- A make-up exam will not be allowed if a mark greater than 100% is required on the make-up exam to pass the course.
- In the event that a make-up exam is required, the highest achievable overall grade for this course will be a C
