I. COURSE DESCRIPTION:

This course carries on from the knowledge learned in AVT112, with an emphasis on the practical application of the Dead reckoning navigation.

II. LEARNING OUTCOMES AND ELEMENTS OF THE PERFORMANCE:

Upon successful completion of this course, the student will demonstrate the ability to:

1. Effectively and quickly use the CR-5 Flight Computer

Potential Elements of the Performance:

conversions, v=d/t, true airspeed, density altitude, headings, groundspeed, winds in flight, 1-in-60 rule, cross-wind component for landings, all done quickly and efficiently Note: no other flight computer will be allowed.

2. retrieve and interpret airport information

Potential Elements of the Performance:

learn to use the Canada Flight Supplement

 apply Dead Reckoning techniques as required by Private and Commercial Pilots

Potential Elements of the Performance:

flight planning, navigation log usage, chart preparation, calculation of navigation data, weight and balance, fuel analysis, using checkpoints for groundspeed calculation, drift correction, lost procedures

4. radio theory and basic navigation aids

Potential Elements of the Performance:

radio theory, VOR, transponders, GPS

 Understand and apply the theory and techniques of dead reckoning navigation, as well as theory of radio navigation aids, required for the completion of the navigation portion of the Transport Canada Private Pilot Exam

Potential Elements of the Performance:

this course prepares students for the Private Pilot exam and the Commercial Pilot exam as well as the applicable qualification exams

- 2. the Canada Flight Supplement
- Dead Reckoning Navigation and Preparation for Cross Country Flight
- 4. Radio Navigation
- 5. Preparation for the Private Pilot and Commercial Pilot written exams

V. EVALUATION PROCESS/GRADING SYSTEM:

The student will be assessed by a combination of attendance and deportment, quizzes, tests and a final exam. Weighting of each will be as follows: 20% for quizzes, 30% for all tests prior to the final exam and 50% for the final exam. A minimum mark of 70% is required to pass the course. Make-up tests are not permitted except in accordance with section VI of this outline.

- Unexcused absences will result in 2% deduction of the final mark for each
 occurrence, arriving for class late will result in a 1% deduction of the final mark for
 each occurrence, and violations of the dress code will result in a 1% deduction of the
 final mark for each occurrence. Refer to the SOP GEN 1.3 for dress code policies
 and SOP GEN 1.6.7 for policy regarding absence from classes
- A 2% deduction of the final mark for every class that a student does not have the required equipment, such as a VNC, plotting instruments, CFS, etc.
- Quizzes will be given without prior notice.
- If it is necessary to write a second final exam in order to pass the course, the highest grade achievable will be a "C". (See make-up policy in section VI)
- Students may request a deferment of a test for compassionate reasons.
 Compassionate Grounds for deferment will include but not be limited to death of an immediate family member, personal illness, or recent diagnosis of a serious illness of a family member. Make-up tests or exams will not be permitted after the fact for compassionate reasons.
- "F" grades in any subject at the end of a semester will result in termination from the Aviation program.

VI. SPECIAL NOTES:

Attitude and Conduct

Attitude plays an important role in your ability to exercise good judgement. Although attitude is not being graded, it affects your ability to learn as well as your safety as a student and future as a professional pilot. Students who display a strong tendency towards any of the five hazardous attitudes pose a grave risk to themselves and others. For this reason, students exhibiting one or several hazardous attitudes will be counselled and if necessary, will be put on a behavioural contract. If this is ineffective in modifying unacceptable behaviour, then the student will be withdrawn from the program.

The five hazardous attitudes are identified as Anti-authority, Impulsivity, Invulnerability, Machismo, and Resignation. These hazardous attitudes are described in "Human Factors for Aviation – Basic Handbook" on pages 151 and 152.

Make-up Policy

- No make-ups on tests occurring prior to final exams.
- No make-ups on quizzes.
- If the final grade achieved for this course is less than 70%, a second final exam may be written at the discretion of the professor for this course. The grading system will be modified as follows: the first exam attempt will be weighted at 25% instead of the original 50% of the final mark, and the make-up exam will be weighted at 25% of the final mark. The minimum mark for the course is still 70% or better after the grade has been re-calculated to include the make-up exam. In the event that a second final exam is required, the highest achievable overall grade for this course will be a C
- Any student that requires 90% or greater on a make-up exam to pass the course will not be allowed to write a make-up exam.
