## I. COURSE DESCRIPTION:

This course deals with the mechanical operations of aircraft engines and engine accessories; recognition of fuels, oils; and the various airframe construction techniques.

# II. LEARNING OUTCOMES AND ELEMENTS OF THE PERFORMANCE:

Upon successful completion of this course, the student will demonstrate the ability to:

Appreciate the need for careful handling of aircraft engines, proper refueling and inspections for contamination. Be knowledgeable of aircraft inspections times and how to maintain the aircraft's Certificate of Airworthiness. The student will also appreciate the need for proper aircraft handling during seasonal changes.

- 3. Intermediate aerodynamics
- 4. Weight and balance and stability
- 5. Performance charts

#### V. EVALUATION PROCESS/GRADING SYSTEM:

The student will be assessed by a combination of attendance and deportment, quizzes, tests and a final exam. Weighting of each will be as follows: 30% for quizzes, 30% for all tests prior to the final exam and 40% for the final exam. A minimum mark of 70% is required to pass the course. - Dates of tests will be announced at least 1 week in advance.
