I. COURSE DESCRIPTION:

Study the IFR air law relating to filing of flight plans, departure, enroute, holding and arrival procedures

II. LEARNING OUTCOMES AND ELEMENTS OF THE PERFORMANCE:

Upon successful completion of this course, the student will demonstrate the ability to:

- 1. Appreciate the safety need for IFR regulations and procedures
- 2. Understand the Canadian Air Regulations with regard to IFR flight
- 4. Study the A.I.M. IFR sections 6 through 10

III. TOPICS:

- 1. Instrument procedures and regulations for flight planning, departure, enroute, arrival and holding
- 1. Study of approach plates, enroute charts, SIDS and STARS
- 2. Integrating Commercial Air Law and Instrument Air Law toward practical flight planning

- 3) Handouts

V. EVALUATION PROCESS/GRADING SYSTEM:

The student will be assessed by a combination of attendance and deportment, quizzes, tests and a final exam. Weighting of each will be as follows: 30% for quizzes, 30% for all tests prior to the final exam and 40% for the final exam. A minimum mark of 70% is required to pass the course. Make-up tests are not permitted except in accordance with section VI of this outline.
