I. COURSE DESCRIPTION:

This course explores the remainder of the radio navigation aids not covered in AVF242, and puts to practice radio navigation as well as dead reckoning skills in preparation for writing the Transport Canada Commercial Written Exam (CPAER).

II. LEARNING OUTCOMES AND ELEMENTS OF THE PERFORMANCE:

Upon successful completion of this course, the student will demonstrate the ability to:

1. use Radio Navigation aids

<u>Potential Elements of the Performance</u>: position fixes, identify position using cross bearings, identify waypoints and intersections, intercepting tracks and airways

2. apply dead reckoning and radio navigation

<u>Potential Elements of the Performance</u>: review of basic dead reckoning navigation, calculate time and distance using bearing changes, reciprocal track, radio reception range

3. demonstrate that they have the knowledge required to pass the navigation section of the Transport Canada Written Exam (CPAER)

<u>Potential Elements of the Performance:</u> final preparation for the Sault College Qualification exam and the Transport Canada exam

IV. REQUIRED RESOURCES/TEXTS/MATERIALS:

V. EVALUATION PROCESS/GRADING SYSTEM:

The student will be assessed by a combination of tests and a final exam. Weighting of each will be as follows: 10% for the projects, 40% for the tests and 50% for the final exam. The final exam will cover all material taught throughout the semester and will approximate the navigation portion of the Transport Canada written exam. Marks will be deducted for unexcused absences (see special notes for details) or for not having navigation equipment with them in class. In order to pass the course, a minimum grade of B must be achieved, otherwise the course must be repeated in accordance with the Aviation Standard Operating Procedures.

- In order to be excused from class due to illness or other unforeseen circumstance, students must call the professor at extension 2666 and leave a message prior to the start of class. An email is also acceptable, but must be sent prior to the start of class.
- Students may request a deferment of a test for compassionate reasons. Compassionate Grounds for deferment will include but not be limited to death of an immediate family member, personal illness, or recent diagnosis of a serious illness of a family member. Make-ups will not be permitted after the fact for compassionate reasons.
- Dates of tests will be announced at least 1 week in advance.

VI. SPECIAL NOTES:

Attendance:

Sault College is committed to student success. There is a direct correlation between academic performance and class attendance; therefore, for the benefit of all its constituents, all students are encouraged to attend all of their scheduled learning and evaluation sessions. This implies arriving on time and remaining for the duration of the scheduled session. It is the departmental policy that once the classroom door has been closed, the learning process has begun. Late arrivers may not be granted admission to the room.

Unexcused absences will result in 2% deduction of the final mark for each occurrence, arriving for class late will result in a 1% deduction of the final mark for each occurrence, and violations of the dress code will result in a 1% deduction of the final mark for each occurrence. To avoid losing marks due to illness, you must contact the professor and leave a voice message (which is time-stamped) or an email PRIOR TO THE START OF THE CLASS. Calling after the class begins will indicate that the student simply slept in and was not in fact sick.

Navigation materials and equipment for each class

There will be many exercises for students to do in class in order to practice the skills that they learn. It is vital that each student get a chance to practice these skills, as it is the only way to properly learn them. It is also vital that each student works alone so they can learn to accomplish those skills unassisted, such as when they have to do it in an airplane or during a Transport Canada written test. If a student does not have the proper material for an exercise, they will not be allowed to work with others, since this would cause a considerable distraction to those classmates. Since not being able to do the in-class exercises is tantamount to not attending class, a deduction of 2% per class will assessed.

For each class, students must have on hand:

- A current Sault Ste Marie VFR navigation chart (VNC)
- ICAO ruler or similar
- Douglas Protractor or similar
- Flight computer
- a current Canada Flight Supplement (CFS)

Cell phones and computers

Cell phones are not required for any part of the class activities. Texting and web use will only cause unnecessary distraction, and therefore is not allowed. Anyone using their cell phone during class may be asked to leave for the duration of the class hour. No deduction in marks will occur. Some students like to use their laptop. This is not necessary since all course material is available both in their textbooks or on LMS. Students are allowed to use them but this permission will be withdrawn if a student is caught using their laptop for non-class related use.

VII. COURSE OUTLINE ADDENDUM:

1. <u>Course Outline Amendments</u>:
