I. COURSE DESCRIPTION:

Study the IFR air law relating to filing of flight plans, departure, enroute, holding and arrival procedures in the context of 703 commercial operations. The course will consist of a series of 10 IFR trips that incorporates air law procedures drawn from the RAC sections 6 to 10 mixed with CARs 703 and 723 regulations and standards to create mission oriented scenarios typical of actual IFR 703 operations. Mid term and final Exams are also included

II. LEARNING OUTCOMES AND ELEMENTS OF THE PERFORMANCE:

Upon successful completion of this course, the student will demonstrate the ability to:

1. Appreciate the practical need to integrate IFR procedures with CARs Regulations and relate them to actual operations
2. The need to be self reliant and take responsibility for knowing all relevant IFR procedure and CARs for a 703 operation
3. Understand the general layout and navigate through the whole A.I.M. to be able to use it as a learning document and as a reference for the professional pilot

III. TOPICS:

1. Study instrument procedures and regulations for flight planning, departure, enroute, arrival and holding based on the RAC sections 6 to 10 and CARs 703/723
2. Interpretation and use of approach plates, the General Section, LO charts, SIDS and STARS integrated into typical IFR 703 operations
3. Review CARs 602, 605 and 605 regulations that apply to all aviation

IV. REQUIRED RESOURCES/TEXTS/MATERIALS:

- 1) Aeronautical Information Manual
- 2) Canadian Air Regulations
- 3) Canada Air Pilot, Gen Section and LO charts

V. EVALUATION PROCESS/GRADING SYSTEM:

The student will be assessed by a combination of attendance and deportment, quizzes, tests and a final exam. Weighting of each will be as follows: 30% for quizzes, 30% for all tests prior to the final exam and 40% for the final exam. In order to pass the course, A minimum grade of B must be achieved, otherwise the course must be repeated in accordance with the Aviation Standard Operating Procedures. Make-up tests are not permitted except in accordance with section VI of this outline.

- Unexcused absences will result in 2% deduction of the final mark for each occurrence, arriving for class late will result in a 1% deduction of the final mark for each occurrence, and violations of the dress code will result in a 1% deduction of the final mark for each occurrence. Refer to the SOP GEN 1.3 for dress code policies and SOP GEN 1.6.7 for policy regarding absence from classes
- Quizzes will be given without prior notice.
- If it is necessary to write a second final exam in order to pass the course, the highest grade achievable will be a "C". (See make-up policy in section VI)
- Students may request a deferment of a test for compassionate reasons. Compassionate Grounds for deferment will include but not be limited to death of an immediate family member, personal illness, or recent diagnosis of a serious illness of a family member. **Make-ups will not be permitted after the fact for compassionate reasons.**
- Although attitude, co-operation, etc., are not graded, students may be terminated based on their performance in this area (see section VI). These attributes are also considered in the selection of the Air Canada Award and other scholarships.
- Dates of tests will be announced at least 1 week in advance.
- A classroom code of conduct can be found in the SOP General section, and will be adhered to.
