Code No.**I. COURSE DESCRIPTION:**

This course is designed to provide students with the level of computer literacy needed to function in today's workplace. Utilizing a hands-on approach, general computer concepts, the concepts of microcomputer operating systems, internet, and word processing applications will be introduced. A personal E-mail account will be introduced and used throughout the course to facilitate good communications between students and faculty and simulate the modern work environment. Students will also be exposed to a variety of early childhood software packages and their usage within childcare settings.

II. LEARNING OUTCOMES AND ELEMENTS OF THE PERFORMANCE:

Upon successful completion of this course, the student will demonstrate the ability to:

1. Apply the knowledge of microcomputer hardware and operating system software concepts to home/work situations. (5% of course content)

Potential Elements of the Performance:

- Describe the main types of computers and their uses.
 - Identify and evaluate a computer in terms of its input, processing, storage, output, and communications components.
 - Explain the importance of system software and applications software and name some common types of each.
 - Login to the network environment at Sault College.
2. Demonstrate proficiency in using an up-to-date operating system for microcomputers. (15% of course content)

Potential Elements of the Performance:

- Identify the elements of a window.
- Perform the four basic mouse operations of pointing, clicking, double-clicking, and dragging.
- Correct errors made with the mouse.
- Understand the keyboard shortcut notation.
- Use the menu commands and dialogue boxes.
- Manipulate windows and icons.

- Start and exit standard accessory applications.
 - Multitask within the Windows environment.
 - Work with files including naming conventions, directory structures, and paths.
 - Obtain online Help while using an application.
 - Identify the applications that come with Microsoft Windows 95.
 - Manage files, folders, and disks using appropriate naming conventions.
 - Create a backup diskette.
 - Follow correct backup practices to ensure data security.
3. Access and navigate the software required to browse the Internet and communicate with co-workers using e-mail. (5% of course content)

Potential Elements of the Performance:

- Open and exit an Internet browser (Netscape Communicator).
 - Recognize and follow hyperlinks.
 - Input known addresses to reach specific web pages.
 - Print/save web pages.
 - Perform simple searches using a variety of search engines.
 - Set up and manipulate bookmarks.
 - Open an e-mail program (Netscape Messenger).
 - Configure the program to reflect personal information.
 - Send messages to others on the same system and elsewhere.
 - View, store, sort, delete, or print incoming messages.
 - Reply to or forward incoming messages.
 - Store commonly used addresses.
4. Demonstrate proficiency in operating a common word processing software package to prepare standard business documents. (60% of course content)

Potential Elements of the Performance:

- Both open and exit from MS Word 2000.
- Recognize the other applications in Office 2000.
- Understand the basic capabilities of word processing software including easy access to the Internet.
- Name Word window parts and defaults.
- Access on-line help.

- Set up automatic features such as autocorrect, autoformat, spelling, and grammar.
 - Create, format, name, save, retrieve, edit, and print a document.
 - Insert clipart from a variety of sources.
 - Change default formatting settings.
 - Move efficiently through documents.
 - Select text effectively.
 - Use text-enhancing features such as bold, underline, italics, fonts, font size, highlight, colour, and animation.
 - Change paragraph formats using indentation, alignment, line spacing and tab settings.
 - Create bulleted and numbered lists.
 - Insert leaders.
 - Work with multiple documents.
 - Copy and move text within documents and between documents.
 - Find and replace text.
 - Use the Autotext, Spelling, Grammar Checker, and Thesaurus tools.
 - Customize toolbars, page layout, and margins.
 - Perform standard report formatting procedures such as preventing widows/orphans, inserting page numbers, creating headers/footers, and inserting a section break.
 - Create newspaper columns.
 - Use printing options including print preview.
 - Use Word's file management commands to create a document inventory and to manage individual files.
 - Use Wizards to increase productivity.
 - Create, format, and edit tables within documents.
 - Apply borders and shading.
 - Use the drawing toolbar.
 - Save a document as a web page.
 - Prepare an envelope and labels.
5. Demonstrate proficiency in selecting and operating early childhood education software packages. (10% of course content)

Potential Elements of the Performance:

- Install, run, and use a minimum of three early childhood software programs.
- Describe factors to consider when selecting early childhood software.
