I. COURSE DESCRIPTION:

This course is designed to provide the accounting major with exposure to a comprehensive windows-based financial spreadsheet package to enhance their problem solving abilities. The package used will be Microsoft Excel 97 for Windows and the student will use this as a tool to prepare various accounting reports and presentations which can be transferred in work commonly performed in the modern office.

II. LEARNING OUTCOMES AND ELEMENTS OF THE PERFORMANCE:

Upon successful completion of this course, the student will demonstrate the ability to:

1. Perform fundamental tasks involving the operation of a spreadsheet package, recognizing that many of the same functions are found as in other spreadsheet productions.

Potential Elements of the Performance:

- Start and exit Excel
- Discover how Excel is used in business
- Identify the major component of the Excel window
- Navigate an Excel workbook and worksheet
- Open, save, print, and close a worksheet
- Enter text, numbers, formulas and functions
- Correct mistakes
- Perform what-if analysis
- Clear contents of cells
- Use the Excel Help system

This learning outcome will constitute approximately 12.5% of the course grade.

2. Apply increasingly challenging practical skills and problem solving abilities to perform numerous tasks in using the Excel software.

Potential Elements of the Performance:

- Plan, build, test, document, preview, and print a worksheet
- Enter labels, values, and formulas
- Calculate a total using the AutoSum button
- Copy formulas using the fill handle and Clipboard
- Learn about relative, absolute, and mixed references

- Use the AVERAGE, MAX, and MIN functions to calculate values in the worksheet
- Spell check the worksheet
- Insert a row
- Reverse an action using the Undo button
- Move a range of cells
- Format the worksheet using Auto Format
- Center printouts on a page
- Customize worksheet headers

This learning outcome will constitute approximately 12.5% of the course grade.

3. Develop a professional looking worksheet.

Potential Elements of the Performance:

- Format data using the Number, Currency, Accounting, and Percentage formats
- Align cell contents
- Center text across columns
- Change fonts, font style, and font size
- Clear formatting from cells
- Delete cells from a worksheet
- Use borders and color for emphasis
- Add text box and graphics to a worksheet using the Drawing toolbar
- Remove gridlines from the worksheet
- Print in landscape orientation
- Hide and unhide rows and columns

This learning outcome will constitute approximately 12.5% of the course grade.

4. Create and enhance the representation of financial information with an Excel chart.

Potential Elements of the Performance:

- Identify the elements of an Excel chart
- Learn which type of chart will represent your data most effectively
- Create an embedded chart
- Move and resize a chart
- Edit a chart
- Change the appearance of a chart
- Place a chart in a chart sheet

- Select nonadjacent ranges
- Work with 3-D chart types
- Add a picture to a chart

This learning outcome will constitute approximately 12.5% of the course grade.

5. Organize data to provide better financial information to interested users within the organization.

Potential Elements of the Performance:

- Identify the elements of an Excel list
- Freeze rows and columns
- Find and replace values in a worksheet
- Change Zoom settings to display a worksheet
- Sort data in a list
- Use a data form to enter, search for, edit, and delete records
- Filter data in a list using AutoFilters
- Apply conditional formatting to a range
- Create natural language formulas
- Insert subtotals into a list
- Use the subtotals outline view
- Insert page breaks using Page Break Preview
- Summarize a list using pivot tables and create a pivot chart

This learning outcome will constitute approximately 12.5% of the course grade.

6. Integrate Excel with other Windows Applications and the World Wide Web.

Potential Elements of the Performance:

- Learn about Object Linking and Embedding (OLE)
- Paste a graphic object into an Excel worksheet
- Embed a WordArt object in Excel
- Link an Excel worksheet to a Word document
- Update linked documents
- Embed an Excel chart in a Word document
- Create hyperlinks to connect files
- Convert worksheet data to HTML format

This learning outcome will constitute approximately 12.5% of the course grade.

7. Use more complicated applications, functions, and macros to save time in performing more complex and \ or repetitive tasks.

Potential Elements of the Performance:

- Arrange a worksheet in sections
- Assign data validation rules to a cell
- Assign and use range names
- Use IF and FV functions in formulas
- Create a series using AutoFill
- Protect worksheets
- Delete unnecessary sheets from a workbook
- Plan and record Excel macros
- Run a macro using menu commands
- Run a macro using a shortcut key
- Run a macro using a button object

This learning outcome will constitute approximately 12.5% of the course grade.

8. Work with multiple worksheets and workbooks, develop and use lookup tables and functions.

Potential Elements of the Performance:

- Insert, name, and move worksheets
- Create worksheet groups
- Edit multiple worksheets at the same time
- Consolidate information from multiple worksheets and workbooks
- Create a lookup table and use Excel's lookup function

This learning outcome will constitute approximately 12.5% of the course grade.
