Students will be introduced to the theory of database concepts and data structures. Data is a valuable resource to companies, and the organizing, creating, maintaining, retrieving, and sorting of data are important activities. Using Access, students will concentrate on transforming raw data into database files that can be queried and organized into accurate, final-form business-style reports and forms.

Upon successful completion of this course, the student will demonstrate the ability to:

1. Use the basic features of Access to track information for businesses or individuals

- Create a table in Datasheet View
- Create an AutoForm for a company
- Create a form using the Form Wizard and Design View
- Work with the controls on a form
- Create a form from the Tables window
- Add a calculated control to a form
- Create a form in Design View
- Refine the appearance of a form
- Create a report suitable for use in a business using Wizard and Design View
- Add a group section and a calculation to a report and use the Format Painter and conditional formatting
- Create a multicolumn report

- Enable the Cascade Update and Cascade Delete options
- Create a lookup field and edit records with a lookup field

Test papers will be returned to the student after grading in order to permit verification of the results and to review the tests. However, the student will be required to return all test papers to the professor who will keep them on file for one year.
