Tests, which use fill in the blank format, may be modified to include a few choices for each question, or a list of choices for all questions. This will allow the student to match or use visual clues.</li> <li>4. Tests in the T/F or multiple choice format may be modified by rewording or clarifying statements into layman's or simplified terms. Multiple choice questions may have a reduced number of choices.</li> <li>C. Tests will be written in CICE office with assistance from a Learning Specialist.</li> <li>The Learning Specialist may: <ol> <li>Read the test question to the student.</li> <li>Paraphrase the test question to the student.</li> <li>Paraphrase the test question without revealing any key words or definitions.</li> <li>Transcribe the student's verbal answer.</li> </ol> </li> <li>D.
