This course provides an intensive, experiential learning opportunity that focuses on further integration of theory and practice at a professional level. There will be a continued emphasis on relational practice and strength-based interventions that enhance development and promote positive change. Students will apply their cumulative knowledge and skills at a level that reflects their readiness for entry level employment as Child and Youth Care practitioners. This course includes 32 hours of placement per week (or equivalent) together with an individualized seminar component (one hour per week) that addresses the outcomes of CYC200 in a compressed format. In order to receive credit for this course, students must also successfully complete its co-requisite, CYC351.
