I. COURSE DESCRIPTION:

This course will review research in the origin and appearance of addiction of various kinds. The course will introduce the student to the impact of addiction to drugs, alcohol and lifestyle, including gambling. Studies will include the effects and cost of addictive behaviour on the individual, the family, the workplace, and society generally. Current research related to prevention and treatment will be introduced.

Article Review (1 or 2):

Each review will involve at least 1 professional articles of information from reliable sources such as professional journals, reputable articles from the internet, magazines or books, etc. on issues related to addictions. Articles must be current (no earlier than 2000). The review should be written APA style and proper spelling and grammar are required.

The paper should be typed and approximately 2 pages in length (double spacing is required). Proper format will be discussed in class with examples.

All papers are due on dates that will be established with the class. Lates (other than substantiated emergencies) will be docked **5 marks per day late** (ie. overnight).

Any emergencies in handing in assignments, performing orals, or writing tests on due dates must be discussed in person or notification made to the instructor by voice mail. Failure to notify the instructor (ext 2564) on or before the date will result in a zero grade for tests or orals.

STUDENTS ARE REQUIRED TO KEEP A COPY OF ALL ASSIGNMENTS SUBMITTED TO THE INSTRUCTOR.

Oral Presentation of Article Review:

Students are required to report the findings of one of their article reviews. They are encouraged to utilize handouts, activities, overheads, blackboards, or discussion with the class during their presentations. Presentations should be 3 to 6 minutes in length if presented by one or two persons. 9 to 12 minutes in length for 3 or 4 persons. There should be no more than 4 persons in a group. Topics for presentations need to be discussed with professor before research is done so there is no duplication of topics for the presentations. Those presenting in a group will need to discuss their own article but it will be on the same topic area. Ie. Cocaine: 1. Effects 2. History 3. Treatment

Survey: Student(s) will develop a survey based on a research article. They will present the survey to 12 to 15 random students and hand in a summary of the results to their questions. Survey will contain at least five questions and will not ask for any names or identifying information. If two people do the survey together they will administer it to 24 to 30 random students and hand in the summary.
