### I. COURSE DESCRIPTION:

This course provides students with the opportunity to connect their classroom learning experiences with community needs. Students will address the service needs of community based organizations through 40 hours of service work. By engaging with current local issues, students will enhance their understanding of social needs, improve their problem solving and critical thinking capacities, develop new relationships in the community, apply teamwork skills and develop a strong sense of social responsibility and active citizenship. The course has a mandatory classroom component where students will meet to use their service experiences to examine and reflect upon topics of democracy, community development, citizenship, diversity and human rights. By the end of the course, students should be able to understand the links between civic engagement, community development and building a culture of peace.

### II. LEARNING OUTCOMES AND ELEMENTS OF THE PERFORMANCE:

Upon successful completion of this course, the student will demonstrate the ability to:

1. Respond to community needs through research, outreach and action.

Potential Elements of the Performance:

- Identify and assess local needs and volunteer opportunities
- Network with local organizations and service providers
- Demonstrate an awareness of different social issues
- Complete 40 hours of volunteer service

# 2. Evaluate the relationship between civic engagement and the quality of life in a community.

Potential Elements of the Performance:

- Discuss the rights and responsibilities associated with being a member of a community
- Outline attributes of an effective citizen
- Discuss the key features of a democratic society
- Identify and Examine core components of thriving communities

### 3. Assess the personal and community impact of service work.

Potential Elements of the Performance:

- Evaluate personal contributions to the community at large and to the organizations with which volunteer work was done
- Review personal highlights and challenges while volunteering
- Recognize personal skills, interests, assets and limitations
- Consider feedback from local organizations about service project(s)

4. Develop interpersonal relationships with different community members.

Potential Elements of the Performance:

- Interact with people from diverse backgrounds in various settings
- Ask questions to better understand a person and those around them
- Demonstrate respect and open-mindedness to other people's ways of thinking and acting
- 5. Relate peace and conflict studies themes and concepts to community service experiences.

Potential Elements of the Performance:

- Write bi-weekly blog posts linking service projects with key peace and conflict studies topics and concepts
- Share service work with peers using a peace and conflict studies perspective
- Reflect on the knowledge, skills and responsibilities of a peace worker

- 5. Diversity
- 6. Democracy
