COURSE DESCRIPTION

This course is a continuation of Fieldwork III Seminar. Students will examine current issues related to the field of the Developmentally Handicapped. In addition, students will look at the role of the Developmental Services Worker and the legislature affecting that role.

OBJECTIVES

- 4. Develop the skills necessary to perform well and prepare further for the job market.
- 5. Discuss issues and/or concerns related to field work in a constructive manner. Utilize problem solving strategies and communication techniques to these issues and concerns.
