

I. COURSE DESCRIPTION:

This course is designed to provide the student, with the necessary skills related to application software for the PC environment (at the introductory post-secondary level.) The student will gain a basic understanding of the operating system Windows 98. Students will learn how to search the internet using various search engines. MS Word, a word-processing package used to create, will be utilized to teach how to create documents. Outlook will be another component of the course where the student will learn e-mail communication and desktop information management.

II. LEARNING OUTCOMES AND ELEMENTS OF THE PERFORMANCE:

Upon successful completion of this course, the student will demonstrate the ability to:

1. Demonstrate the use of Outlook 2000.

Potential Elements of the Performance:

Use Outlook 2000 to

- create and print a contact list
- utilize appointment list
- create a task list
- compose, send and receive e-mail
- attach a file
- use the contact list
- create mail folders
- utilize mail folders
- employ listserves

This learning outcome will constitute 15% of the course.

2. Utilize the internet to research information.

Potential Elements of the Performance:

- explain terminology related to the internet
- start and close browser
- use search engines to find information
- perform common tasks like: research flight schedules, locate city maps, rent a car.
- complete commercial activities such as: find government information, ship and track packages, shop for products.
- conduct a job search

This learning outcome will constitute 20% of the course.

3. Produce a multi-page document containing special formats using Word 2000.

Potential Elements of the Performance:

a) Basic word processing

- name and use all the keys on the keyboard
- define wordwrap, otype, insert.
- distinguish between the insert and otype modes
- create, save, retrieve, edit and print a simple document
- spellcheck a document, use AutoCorrect, and use the thesaurus.
- utilize keyboard shortcuts
- use grammar check

b) Select-Then-Do Commands

- use find, replace, and go to commands
- use format font commands
- use format paragraph, borders and shading, page setup

c) Enhancing a Document: The Web and other Resources

- describe object linking and embedding
- insert clip art and/or a photograph
- use format picture commands
- use wordart
- utilize the Web toolbar
- insert a hyperlink, and/or footnote or endnote
- use wizards and templates to create a document

This learning outcome will constitute 25% of the course.

4. Produce a computer-generated document using advanced features: outlines, tables, styles, and sections.

Potential Elements of the Performance:

- create a bulleted or numbered list which includes multi-levels
- create a table and insert into a document
- use autoformat commands
- create headers footers, insert page numbers
- create an index and a table of contents

This learning outcome will constitute 12.5% of the course.

5. Demonstrate knowledge of disk, directory and file structures.

Potential Elements of the Performance:

- use the Windows desktop
- utilize the Help function
- format a floppy disk
- create, organize folders
- copy and/or move files
- identify different file extensions
- utilize basic dos commands

This learning outcome will constitute 15% of the course.
