I. COURSE DESCRIPTION:

The course will overview the tools Visual Basic has to offer, and how to incorporate the various components into Visual Basic applications. The course will focus on introductory application building as well as the features of the language are covered, and the programming environment. We will be using Microsoft's .NET Framework as the integrated development environment. Once the student becomes familiar with Visual Basic's programming environment, he / she will be ready to create their own programs. In doing so, we will cover setting property values of objects, writing code, testing programs, saving/opening/modifying existing projects, as well as the common controls, students will work with ActiveX controls. The course will guide the students in comfortably creating a Visual Basic front-end to a database application. The end-result will be the packaging of your Visual Basic projects into complete Windows applications including the creation of a setup file.
