The course will overview the tools Microsoft Visual Basic has to offer to build applications in Business and Geographic Information Systems, and how to incorporate the various components into these applications. The course will focus on introductory application building using Visual Basic .Net.

Once the student becomes familiar with the Visual Basic programming environment, the student will be ready to create their own programs, including programs for GIS. In doing so, the course will cover objects, properties, events, code development and testing. The course will also guide students to creating a Visual Basic front-end for database applications.

**Eligibility for X Grades/Upgrading of Incompletes** When a student's course work is incomplete or final grade is below 60%, there is the possibility of upgrading to a pass when a student meets all of the following criteria: The student's attendance has been satisfactory. An overall average of at least 50% has been achieved. The student has not had a failing grade in all of the theory tests taken. The student has made reasonable efforts to participate in class and complete assignments.

Note: The opportunity for an X grade is usually reserved for those with extenuating circumstances.
