## **I. COURSE DESCRIPTION:**

This course is designed to provide the student with a sound working knowledge of and a high degree of skill in the use of multimedia presentation software for the purpose of developing techniques related to the creation of effective Internet Web pages and Multimedia Presentations.

Microsoft Power Point will be used to create advanced multi media presentations that will also be published as Internet Web pages. Students will learn to create and incorporate various file types in their presentations and web pages.

Students will learn basic HTML coding techniques to create Internet Web Pages incorporating multimedia files, forms, frames and tables in addition to image mapping techniques.

Students will also be exposed to an application product, which will allow them to organize and create Internet Web Pages incorporating the various multi media file formats.

Modern computer applications now include audio, images, graphics and video as well as text based information. Students will therefore be expected to use the different multimedia file types within the above software applications to create and deliver an effective multi-media presentation that demonstrates their skill and interpersonal skills to potential employers.

## **II. LEARNING OUTCOMES AND ELEMENTS OF PERFORMANCE:**

**Upon successful completion of the course the student will demonstrate the ability to:**

- 1. Demonstrate an understanding of how to create various multimedia file types.**

Potential elements of the performance:

- Understand Image File Formats JPEG, GIF, Animated Gif
- Use Digital Camera/Scanner to create image file formats.
- Understand video file formats MPEG, AVI
- Use Camcorder to create videos for use in presentations.
- Understand file compression techniques.
- Understand how to create and use Sound Wav and MIDI file types
- Understand how to digitise your voice for use in presentations.

**2. Demonstrate the use Power Point to create effective slide and multi media presentations.**

Potential elements of the performance:

- Understand the Power Point window and Toolbar
- Use design templates.
- Insert text and titles into a slide.
- Format text size and font color.
- Insert and move graphics on a slide.
- Use animated charts and voice narration.
- Insert sound and video into a slide.
- Animate text presentation in a slide.
- Insert Videos into slides
- Insert, delete and re order slides.
- Use bullets and charts in a slide.
- Create slide backgrounds using pictures.
- Work with slides in OUTLINE VIEW
- Save and run a slide show.
- Change background and foreground colors on a slide.
- Set an automatic slide show to run continuously.

**3. Demonstrate the use of Power Point to publish Internet Web pages.**

Potential Elements of the performance:

- Capture sound, graphics and text from the Internet to insert onto a slide.
- Create interactive presentations.
- Publish slides as a series of web pages.
- Use custom animation.
- Set up action buttons and hyper links.
- Save as a web animation file and imbed into web pages.
- Learn about Power Point Viewer.
- Learn to create a complete Web based presentation using Power Point and the Internet

**4. Demonstrate the use of HTML to create and publish Web Pages**

Potential elements of the performance:

- Understand the basic structure of a Web Page
- Understand and use Basic HTML tags
- Understand HTML links
- Create Web pages incorporating Graphics, Sound and Video
- Understand how to create and use Frames
- Understand how to create and use Tables
- Understand how to create and use image mapping
- Understand how to create basic forms and use the <mailto:> function.
- How to incorporate java script in a web page
- Understand how to post your web pages to a server.

**5. Demonstrate the use of Application software to create and publish Web Pages**

Potential elements of the performance:

- Understand how the software basically works to create the following:
- Create and Use various Links
- Create and Use Menus
- Create Web pages incorporating Graphics, Sound and Video
- Understand how to create and use Frames
- Understand how to create and use Tables
- Understand how to create and use image mapping
- Understand how to create basic forms and use the <mailto:> function.
