## NURSING PRACTICE CLINICAL EXPERIENCE

#### CLINICAL OBJECTIVES

YEAR 2

1983

The student demonstrates the use of the nursing process for selected clients who require intervention to regain adaptation.

# A. ASSESSMENT

The student assesses selected clients who require intervention to regain adaptation.

The student 1) uses relevant method and source of data collection,

- collects data about client's overt and covert behaviour in each mode.
- 3) classifies- client's responses as adaptive or ineffective (and can support the classification).
- 4) analyzes collected data to identify the focal, contextual and residual stimuli which influence the adaptive and ineffective responses.
- 5) identifies the adaptation level of the client,
- 6) evaluates adequacy of the data collected and obtains additional data when necessary,
- 7) identifies nursing diagnosis that is consistent with and supported by assessment data.

## B. PLANNING

The student develops a nursing care plan for selected clients who require intervention to regain adaptation.

The student 1) bases care plan on nursing assessment.

- 2) involoves client and family in decisions affecting client's care.
- 3) establishes priorities independently.

- 4) identifies short and long-term client goals in regaining adaptation.
- 5) maintains and promotes client's adaptive resources.
- 6) chooses nursing measures that are most likely to achieve identitied goals for adaptation.
- 7) develops a teaching plan to meet the learning needs of selected clients.
- 8) relates nursing care plan to the plan of care of other health team members.
- 9) refers clients to other hospital health team members.
- 10) refers clients to community agencies. (desirable)
- 11) organizes nursing care to use energy, materials and time efficiently.
- IZ) identifies the dependent, independent, and interdependent functions in the nurse's role,

## C. IMPLEMENTATION

The student implements nursing care as planned to assist selected clients to regain adaptation.

The student 1) carries out nursing interventions consistent with plan.

- 2) carries out nursing skills consistent with scientific principles.
- 3) maintains a safe and therapeutic environment,
- 4) encourages client to carry out activities of daily living in the client's usual fashion.
- 5) makes effective use of time, energy and

- 6) can adjust plan to meet unexpected situations.
- 7) can cope with stressful situations with assistance.
- 8) records and reports significant information promptly and concisely.
- 9) demonstrates awareness of the effect of own behaviour on other people.
- 10) develops a therapeutic relationship
   with clients,
- 11) uses effective interviewing techniques.
- 12) uses communication techniques which
  - a) an appropriate response to the client's verbal

  - b) appropriate and relevant to the situation
- 13) interacts effectively with all age groups
- 14) communicates effectively with nursing team and other hospital health team members-
- 15) demonstrates behaviour which reflects the acceptance of the belief of man's worth and dignity.

## D. EVALUATION

The student will evaluate the achievement of the goals set to assist the selected clients to regain adaptation.

The student 1) identifies client behaviour which will illustrate achievement of goal.

- 2) assesses client's actural behaviour against goal set.
- 3) revises plan and implements modified plan.
