COURSE NAME

L PHILOSOPHY/GOALS:

This course will discuss the health care system, its members, and their roles. It will discuss the legalities, the rights and responsibilities of both the consumer and the PSW. This course will teach you what the terms illness and disability mean to you and to others and the impact that they have. You will learn that the aging process is a normal phase of growth and development and how it impacts on life styles. You will explore how the consumer enters the health care system. You will learn about optimum support and how the personal support worker can promote support. You will learn the skills necessary to promote interpersonal relationships. You will learn the actual steps to problem solving and conflict resolution and about positive group functioning.

In this course you will also acquire general and specific knowledge and skills that will assist you and the consumer to remain safe in the environment and reduce the risk of injury, illness or death.

- d. Describe why stress is a fact of life.
- e. Identify the effects of stress.
- f Identify ways to cope with stress.
- 2) Identify- the health care system its members, and the services they provide

POTENTIAL ELEMENTS OF THE PERFORMANCE

- a. Explain the health care system and identify available resources for consumers.
- b. Identify various members of the health care team.
- c. Identify the members of the nursing team and the impact that the PSW has with regard to the care of the consumer.

- c. Define culture and recognize its affect on individuals and families.
- d. Identify differences and similarities between individuals and cultures.
- e. Describe the structure and function of family relationships.
- f. Identify measures to promote effective working relationships with family members.
- 4) Describe the role of the PSW, as a member of the health care team and the scope of practice for providing support to consumers and their families.

POTENTIAL ELEMENTS OF THE PERFORMANCE

- a. Define the role of the PSW.
- b. Identify the qualities and characteristics of the PSW.
- c. Explain the rights and responsibilities of the consumer and the PSW.
- d. Identify the basic legal issues involved in health care.
- e. Identify situations when a consumer's rights have been violated.
- f. Identify ways to encourage effective working relationships with family members.
- 5) Describe how illnesses and disabilities have an impact on you and others.

POTENTIAL ELEMENTS OF THE PERFORMANCE

- a. Describe illness and disability as sources of stress, and how the individual and the family react to this stress.
- b. Identify common reactions that occur with illness and disability.
- c. Explain the impact of illness and disability on individuals and families.
- d. Describe the aging process as a normal phase of growth and development and the special needs that the elderly consumers have.

- b. Identify the factors that influence communications.
- c. Describe the therapeutic techniques of attentive listening, touch, silence, and verbal responses to promote effective communication.
- d. Identify barriers to therapeutic communication.
- e. Identify measures for interacting with consumers that promote an effective interpersonal relationship.
- f . Identify measures for interacting with families and visitors that promote an effective interpersonal relationship,
- g. Recognize interviewing as an information gathering interaction,
- h. Conduct an interview.

- 11) Maintain safety while providing care for the consumers in their homes and in health care facilities.

POTENTIAL ELEMENTS OF THE PERFORMANCE

- a. Identify safety hazards in the home and in health care facilities.
- b. Describe personal and environmental risk factors that increase the risk of accidents in a home and in health care facilities.
- c. Identify safety measures that can be implemented to reduce risk of injury in the home and in health care facilities.
- d. Identify the common causes of fires in a home and in a health care facilities.
- e. Identify potential fire hazards in the home and in health care facilities.
- f. Describe safety measures that can be implemented to reduce the risk of fire in homes and health care facilities.
- g. Describe actions to take in the event of a fire in a home or in health care facilities.
- 12) Maintain the safety of selves and consumers in the work environment.

POTENTIAL ELEMENTS OF THE PERFORMANCE

- a. Recall information pertaining to the Occupational Health and Safety Act and WHMIS training and recognize their relationship to safety in the environment.
- b. Identify safety precautions in an environment where oxygen is in use.
- c. Describe the PSWs responsibility when discovering faulty oxygen equipment.
- d. Describe the importance of having an identified Disaster Plan in a health care facility.
- e. Identify common principles of medical asepsis
- f. Differentiate between pathogens and non-pathogens.
- g. Identify the methods by which microorganisms are spread in the environment,
- h. Describe the importance of handwashing as an effective method of infection control,
- i. Demonstrate effective handwashing technique.
- j. Identify aseptic measures a PSW should practice in a health care facility to prevent the spread of microorganisms.
