This course will provide the student with a variety of nursing practice settings where they can interact with clients and families experiencing multidimensional health challenges. The student will collaborate with individuals and families to promote health. The student will apply the theories and concepts examined and explored in the co-requisite Health & Healing course. All nursing skills will be practised and applied to maintain and promote health in a variety of nursing practice settings.

Attendance for this course is mandatory. Students must participate in all activities organized in the nursing practice setting.

- 1. devise and implement a variety of increasingly multidimensional, holistic, caring actions
- 2. express and understand the meaning of health as experienced by individuals, families, groups and communities.
- 3. apply knowledge of theoretical concepts and health determinants to deepen the understanding of the lived experience of individuals and families.
- 4. establish caring relationships through which actions are taken to enhance health.
- 5. practise nursing with individuals and families that reflect the practice concepts of:
 - caring and competency
 - caring and interpersonal skill
 - caring and professionalism
 - caring and practice judgement
 - caring and health and healing
- 6. develop learning outcomes and a portfolio based on own learning needs, the practice concepts and Standards of Practice.

The student will also be successfully critiqued on designated nursing skills in the Nursing Resource Centre.
