I. COURSE DESCRIPTION:

This course introduces and utilises terminology used to describe the body and its movement. The major muscles and muscle groups of the human body are introduced while the skeletal system is explored in depth.

II. LEARNING OUTCOMES AND ELEMENTS OF THE PERFORMANCE:

Upon successful completion of this course, the student will demonstrate the ability to:

- 1. Utilise specified terminology related to the structure and function of the human body.
- 2. Recognise the locations and names of major muscles and muscle groups of the human body.
- 3. Recognise and name all the bones of the human body as well as all the structures found on each bone.
- 4. Describe the structures of axial and appendicular skeleton.
- 5. Explain and classify the structure and function of each type of joint found in the human body.
- 6. Describe a typical synovial joint and associated structure.
- 7. Recognise, name and describe the attachments and functions of all the ligaments in the human body.
- 8. Recall the names of the teeth.
- 9. Describe bursae and tendon sheaths

V. EVALUATION PROCESS/GRADING SYSTEM:

Evaluation Methods:

The evaluation methods will be determined and discussed with students during the first two weeks of class.

Missed Exams:
