I. COURSE DESCRIPTION:

This course involves the recognition, palpation, and description of the locations of all the palpable ligaments, nerves, blood vessels, fascia and organs in the human body. A regional approach will be utilised, therefore prior knowledge of bony structures and muscles will also be integrated and descriptions of particular regions (triangles, soft tissue fossae etc.) will also be studied.

Note: Students will be held responsible for prior knowledge of bony structures and muscles.

II. LEARNING OUTCOMES AND ELEMENTS OF THE PERFORMANCE:

Upon successful completion of this course, the student will demonstrate the ability to:

- 1. Recognise and label all bony and soft tissue structures on peers and biology models.
- 2. Palpate all palpable bony and soft tissue structures on the human body.
- 3. Describe or explain the location of all bony and soft tissue structures on the human body.
- 4. Palpate and describe the location, boundaries and structures within special regions (triangles, soft tissue fossae, tunnels, etc.) of the human body.

III. TOPICS:

- 1. Palpation of bony and soft tissue structures
- 2. Description and palpation of special regions of the body

Evaluation Methods:

The evaluation methods will be discussed and a written copy will be given to students during the first two weeks of class.

Supplemental Exam:
