I. COURSE DESCRIPTION:

This course involves the recognition, palpation, and description of the locations of all the palpable ligaments, nerves, blood vessels, fascia and organs in the human body. A regional approach will be utilised, therefore prior knowledge of bony structures and muscles will also be integrated and descriptions of particular regions (triangles, soft tissue fossae etc.) will also be studied.

II. LEARNING OUTCOMES AND ELEMENTS OF THE PERFORMANCE:

Upon successful completion of this course, the student will demonstrate the ability to:

- 1. Recognise and label all bony and soft tissue structures on peers and biology models.
- 2. Palpate all palpable bony and soft tissue structures on the human body.
- 3. Describe or explain the location of all bony and soft tissue structures on the human body.
- 4. Palpate and describe the location, boundaries and structures within special regions (triangles, soft tissue fossae, tunnels, etc.) of the human body.

III. TOPICS:

- 1. Palpation of bony and soft tissue structures
- 2. Description and palpation of special regions of the body

IV. REQUIRED RESOURCES/TEXTS/MATERIALS:

Biel, Andrew. (2001). <u>Trail Guide to the Body.</u> (2nd ed.). Books of Discovery.

Note: Students will be held responsible for prior knowledge of bony structures and muscles.

V. **EVALUATION PROCESS/GRADING SYSTEM:**

Evaluation Methods:

The evaluation methods will be discussed and a written copy will be given to students during the first two weeks of class.

Supplemental Exam:

One opportunity for a supplemental exam will be offered to students who meet the following criteria:

- a) have a grade of 50 59% in the course
- b) have attended at least 80% of the scheduled class time

The final grade for the semester will be based solely on the supplemental exam. The grade achieved will not be higher than a "C".
