I. COURSE DESCRIPTION:

The purpose of this course is to familiarize students with the roles and responsibilities of an OTA/PTA. It will prepare the student for fieldwork experience by introducing important concepts and practical experiences which will assist them to function safely and effectively in occupational therapy and physiotherapy settings. Tours and observational experiences of health care and rehabilitation settings will be arranged depending on availability.

II. LEARNING OUTCOMES AND ELEMENTS OF THE PERFORMANCE:

In general, this course addresses Vocational Learning Outcomes (cross-referenced with the Program Standards) in: communication skills (1, 2, 3, 6), interpersonal skills (1, 2, 3, 7), safety (1, 2, 4), professional competence (1, 2, 4, 5, 6, 7), documentation skills (1, 4, 5, 6), and application skills (1, 2, 4, 6). It addresses all of the Generic Skills Learning Outcomes with the exception of mathematical skills (4).

Upon successful completion of this course, the student will:

1. Demonstrate an understanding of the School of Health Sciences Philosophy and the OTA/PTA Program Policies.

- Discuss the OTA/PTA Program Policies
- Discuss the responsibilities of the student and the College

2. Demonstrate an understanding of the roles/responsibilities of the OTA/PTA and other support personnel, and their educational preparation.

- Explain the developing role of support personnel, assistants, aides, etc. and identify their educational preparation
- Identify roles and responsibilities of the OTA/PTA and other support personnel in various fieldwork settings

3. Demonstrate knowledge and application of professional behaviours expected of an OTA/PTA.

Potential Elements of the Performance:

- Discuss the differences between professional versus nonprofessional occupations
- Identify professional versus non-professional behaviours
- Describe professional behaviours expected of an OTA/PTA

4. Describe and adhere to the concept of confidentiality, the OTA/PTA's responsibilities regarding confidentiality and the consequences of breaching confidentiality.

Potential Elements of the Performance:

- Describe the underlying principles of confidentiality
- Describe the responsibilities of the OTA/PTA regarding confidentiality
- Explain/identify the consequences of any breach of confidentiality
- 5. Demonstrate an understanding documentation and of the organization and presentation of a medical record.

Potential Elements of the Performance:

- Define documentation and explain its significance
- Discuss the role of documentation in patient care
- · Describe the organization of a medical record
- Describe a SOAP note
- Identify the responsibilities of the OTA/PTA related to reporting unusual incidents
- 3. Demonstrate knowledge and skills related to the principles of medical asepsis.

Potential Elements of the Performance:

- Describe the underlying principles of medical asepsis
- Describe and demonstrate procedures related to maintaining medical asepsis
- 4. Demonstrate knowledge and skills related to the OTA/PTA's responsibilities related to risk management.

Potential Elements of the Performance:

- Discuss Emergency Codes
- Describe principles related to fire safety
- Identify the responsibilities of the OTA/PTA related to fire safety
- 8. Demonstrate knowledge of effective office organizational skills.

Potential Elements of the Performance:

- Describe and demonstrate appropriate office management skills including:
 - reception/clerical duties (answering the telephone, recording messages, booking appointments, filing charts, use of computer software (Word, Excel, Powerpoint etc.)
 - taking inventory
 - ordering supplies
 - maintaining a clean/tidy work environment
 - > set up and clean up of treatment areas and assessment areas
 - help to prepare client for therapy
- Explain the necessity of and demonstrate organizational skills that manage time and reduce stress in the work environment

9. Demonstrate knowledge and skills related to the use of audiovisual equipment used in client and peer education (for example, TV, VCR, slide projector, LCD projector etc).

- Describe and demonstrate correct use of the following audiovisual equipment:
 - > television/VCR
 - slide projector/LCD projector
 - video camera

- 2. **Submission of all of the necessary fieldwork requirements listed in Learning Outcome #10 is required in order to receive a Passing Grade in this course.
- 3. Students missing any of the tests or exams because of illness or other serious reason must notify the professor **BEFORE** the test or exam. The professor reserves the right to request documents to support the student's request.
- 4. Those students who have notified the professor of their absence that day will be eligible to arrange an opportunity as soon as possible to write the test or exam at another time. Those students who <u>DO NOT NOTIFY</u> the professor will receive a zero for that test or exam.
- 5. For assignments to be handed in, the policies of the program will be followed. For assignments not handed in by the due date, the mark received will be zero. Extensions will be granted if requested in writing at least 24 hours before the due date. There will be a deduction of one percent per day for every school day late with the permission of an extension. This means that an extension for 5 school days (1 week), will result in 5 percentage points deducted from the final grade.
- 6. A supplemental exam/assignment may be written by students who meet the following criteria. The student must achieve at least a grade of 45% in the course. The student must have attended at least 80% of the classes. The supplemental exam/assignment will then cover the entire course and will be worth 100% of the student's final mark.
