I. COURSE DESCRIPTION:

In this course various modes of nursing inquiry will be addressed. Some of these include scientific, empirical, philosophical and historical modes. Relationships between practice, theory, and research will be explored. Past and present contributions to nursing knowledge will be discussed.

II. LEARNING OUTCOMES AND ELEMENTS OF THE PERFORMANCE:

Ends-in-View

The purpose of the nursing inquiry course is to provide the student with an opportunity to further explore the process of inquiry in nursing. The focus of this course is on the profession of nursing and knowledge development of the profession. Through readings, the student will have the opportunity to critically examine how nurses "know" and the process of inquiry in nursing. Students will also have the opportunity to explore their own processes of knowing and to engage as an active participant in the development of the growing body of knowledge in nursing

Process

Praxis is the underlying process that will be used in the course. Critical reflection on self, values, ways of knowing, experience, context, and theory will be integrated. The intent is that students engage in an interactive process with the nursing literature and their own practice. Preparation, discussion, learning activities, and written exercises will be used

<u>LMS</u>

Each of the learning activities has associated online discussion questions. It is a requirement of the course that students post responses to these questions. These responses are meant to focus learners on some of the integral elements of discussion from each week's Learning Activity. The LMS responses will be the starting point for further discussion. They need to be a thoughtful, succinct (maximum of 300 words) and critical discussion of each week's Learning Activity content. They should be a representation of the student's beginning understand of the course content.

They will not be marked or corrected by the course professors but are meant to be a class discussion of the knowledge associated with the week's Learning Activity. Students are encouraged to read and respond to other student's postings to enhance their own understanding of each week's Learning Activity. These LMS postings, combined with the in class discussion of the knowledge associated with each Learning Activity, will serve as a foundation for the overall understanding of nursing knowledge and inquiry and the student's ability to critically examine, discuss and apply this essential course content. Referencing is required. Failure to meet the posting requirements for the course will result in the loss of 50% of the LMS assignment mark.

III. TOPICS:

- 1. The nature of knowledge/ontology
- 2. Ways of knowing/epistemology
- 3. Literature review preparation
- 4. Conceptual thinking
- 5. Nursing paradigms, models, and theories
- 6. Praxis

IV. REQUIRED RESOURCES/TEXTS/MATERIALS:

There is textbook required for this course. Required readings related to each learning activity will be assigned. These readings consist of current and classic articles relevant to the subject of nursing inquiry.

Packages, containing all required and recommended readings, will be available for purchase through the Sault College Bookstore.

V. ATTENDANCE

Punctual and regular attendance at the various academic exercises is required of all students. If there are extenuating circumstances bearing upon a student's absence, the instructor should be notified. Absences in excess of 20% may jeopardize credit for the course.

VI. EVALUATION PROCESS/GRADING SYSTEM:

A passing grade of 60% is required for all nursing courses. The grade for NURS 3406 will be based on the following methods of evaluation as described below. Further information about the evaluation methods are detailed in the course syllabus.

1. LMS: 20%

Two (2) postings from the LMS section of the Learning Activities will be submitted for grading. The topics for the LMS postings occur at the end of each unit. Each posting must reflect the essence of the topic and is to be no longer than 300 words. These postings are not informal discussion. They need to be a learned, succinct, and referenced discussion which illustrates the reflection which you have engaged in with the literature, your own experience and the assigned topic.

Posting #1 – 5% Posting #2 – 15%

2. Descriptive Literature Review: Marks: 50% Due Date: TBA

Complete a descriptive literature review on a topic that is relevant to your nursing practice. The review must describe knowledge related to your selected topic from referred nursing research and theoretical journals. The paper should include an introduction that outlines the significance of the topic to nursing and the intention of the review; a review of appropriate literature; and a summary of your review. The body of the paper is to be no more than 5 type written pages

The school policy on written assignments applies to all written assignments. APA (5th ed.) format is required. Students may lose up to 10% of the total possible mark for poor form and writing style. It is expected that students who have experienced difficulties with writing competency in past courses will seek writing assistance before submission of the formal paper.

One hard copy of each assignment must be submitted. Further information about the procedure for submission of assignments electronically can be found in the course syllabus. *If, for personal reasons, you are not able to meet the deadline, it is your responsibility to contact the course professor <u>prior</u> to the due date. If an extension is granted, you are required to document your situation and request in writing, and submit this request to the course professors within two days of the original request. <u>Extensions will not be granted on the day that the assignment is due</u>. There will be a daily deduction associated with all extensions unless a medical certificate is submitted with the request. Both hard copies and submissions to Turnitin must be submitted by the due date and time to be considered on time.*

3. Final Exam: Marks: 30%

The final exam will be held in the University exam period. The questions will consist of five questions. Four of these questions will be from the five LMS postings..

NOTE:
