#### I. COURSE DESCRIPTION:

This course introduces the learner to the concepts of pharmacology as selected drug groups are studied. The course will emphasize the role and responsibilities of the practical nurse in the administration and monitoring of client medications.

Upon successful completion of this course, the student will demonstrate the ability to:

1. Explain the action and interaction of selected classifications/pharmaceutical preparations and the impact on nursing care:

#### Potential Elements of the Performance:

- discuss relevant information related to administering medications for each of the drug classifications.
- explain safe practices in administering and monitoring medications following the Standards from the College of Nurses of Ontario.
- formulate relevant health teaching related to medication administration

#### III. TOPICS:

- 1. Antiinfectives and Antiinflammatory Agents
  - antibiotics
  - antivirals
  - antituberculars
  - antifungals
  - antimalarials, antiprotozoals, and anthelmintics
  - antiseptics and disinfectants
  - anti-inflammatory, antirheumatoid and related agents
- 2. Drugs Affecting Fluid and Electrolyte Balance
  - diuretics
  - agents affecting volume and ion content of body fluids
- 3. <u>Anesthetics and Analgesics</u>
  - local and general anesthetics
  - narcotic and non-narcotic analgesics
- 4. Drugs Affecting Integumentary System
  - topical medications

## 5. Drugs Affecting Respiratory System

- bronchodilators
- antihistamines
- nasal decongestants
- antitussives
- mucolytics
- cold remedies

#### 6. Drugs Affecting Cardiovascular System

- drugs to treat heart failure
- antiarrhythmics
- antianginals
- antihypertensives
- drugs used in hypotension and shock
- drugs affecting blood coagulation
- drugs for hyperlipidemia

## 7. Drugs Affecting Gastrointestinal System

- antacids and acid controllers
- laxatives
- antiemetics
- antidiarrheals
- nutritional supplements
- vitamins and minerals
