COURSE NAME

I. COURSE DESCRIPTION:

This course will provide the student with a variety of nursing practice settings where they can interact with clients and families experiencing multidimensional health challenges. The student will collaborate with individuals and families to promote health. The student will apply the theories and concepts examined and explored in the co-requisite Health & Healing course. Nursing skills will be practised and nursing theory will be applied to maintain and promote health in a variety of nursing practice settings.

Attendance for this course is mandatory. Students must participate in all activities organized in the nursing practice setting.

II. LEARNING OUTCOMES:

Upon successful completion of this course, the student will have reliably demonstrated the ability to:

- 1. provide safe, effective and ethical nursing care which meets the current Standards of Nursing Practice for Registered Nurses of the College of Nurses of Ontario;
- 2. care for a client population including individuals, families, groups and communities from a variety of backgrounds;.
- 3. promote health and healing for individuals, families and groups experiencing multidimensional health problems;
- 4. practice nursing based on the concept of praxis;
- 5. demonstrate caring behaviours in relationships with individuals and families;
- 6. develop personal learning outcomes for practicum based on own learning needs, practice concepts and the CNO "Standards of Practice";
- 7. demonstrate satisfactory achievement of personal learning outcomes through ongoing portfolio development (reflective practice).

III. TOPICS:

Students will practice in a variety of nursing practice settings. Practice settings may include:

- hospitals
- community agencies
- clinics

Students are encouraged to utilize the Health Sciences Resource Centre to practice clinical skills, as necessary, to maintain competency.

IV. REQUIRED RESOURCES/TEXTS/MATERIALS:

All semester 1,2,3,4, and 5 texts.

Lab Kit equipment from Year 1 and Year 2 may be necessary for lab practice.
