I. COURSE DESCRIPTION:

This course will expand the student's knowledge base acquired in the course HUMAN MOVEMENT. The student will be introduced to basic clinical competencies and will have the opportunity to apply the principles of normal functional movement as it relates to exercise, posture, and transfers. The student will gain skill in proper handling techniques, the use of assistive ambulation devices and the measurement of joint motion.

II. LEARNING OUTCOMES AND ELEMENTS OF THE PERFORMANCE:

In general, this course addresses Vocational Learning Outcomes (crossreferenced with the Program Standards) in: communication skills (1, 2, 8P, 8O, 9P, 9O, 10P, 10O), safety (1, 2, 4, 8P, 8O, 9P, 9O, 10P, 10O), professional competence (1, 2, 4, 5, 7, 8P, 8O, 9P, 9O, 10P, 10O), documentation skills (1, 4, 5) and application skills (1, 2, 4, 8P, 8O, 9P, 9O, 10P, 10O). It addresses all of the Generic Skills Learning Outcomes.

Upon successful completion of this course, the student will:

1. Demonstrate and apply knowledge and skills related to the assessment of motor development.

Potential Elements of the Performance:

- Explain and demonstrate the normal stages of motor development and identify the implications of failure to achieve these
- Describe key milestones used to assess motor development
- 2. Demonstrate and apply knowledge related to concepts of movement. <u>Potential Elements of the Performance</u>:
 - Describe the clinical implications of the essential components of movement (motor, sensory, cognitive, perceptual, psychosocial, environmental) and their inter-relationship
 - Integrate knowledge of concepts of movement and joint movement through the analysis of normal functional movements (ie. Walking, throwing a ball, lifting a box etc.)
- 3. Demonstrate and apply knowledge and skills related to muscle and exercise physiology.

Potential Elements of the Performance:

 Integrate knowledge of muscle and exercise physiology through the analysis of various normal functional movements 4. Demonstrate and apply knowledge related to body alignment and positioning, transfers and lifts.

Potential Elements of the Performance:

- Describe and demonstrate normal body alignment and positioning
- Demonstrate the ability to assist and educate others regarding normal body alignment and positioning
- Describe and demonstrate the safe use of basic transfers (1 and 2 person); their functional sequences and assistive devices for their safe completion
- Identify and define tone, balance, and cognitive status and explain how they may affect transfers
- Identify risk factors and contraindications in the use of lifts and transfers
- Identify appropriate selection and application of various transfer techniques in simulated clinical situations
- 5. Demonstrate safe and purposeful handling for normal limbs. <u>Potential Elements of the Performance</u>:
 - Describe and explain the purpose of Passive Range of Motion, Active Range of Motion, Active Assistive Range of Motion and Resistive Movement
 - Demonstrate and explain the need for safe handling of limbs
 - Identify and define tone, cognitive status and explain their effect on handling of limbs
 - Explain the effects of improper handling techniques on the patient
- 6. Demonstrate an understanding of the implications of age-related changes on normal functional movement.

Potential Elements of the Performance:

- Describe the implications of normal age related changes on:

 a)bones
 b)joints
 c)muscles
 d)posture
 e)movement specific joints, spine, chest wall
 f)cardio-respiratory systems
- 7. Demonstrate and apply knowledge related to the assessment of joint movement.

Potential Elements of the Performance:

- Define and describe goniometry
- Explain the essential components of reliable, valid goniometry
- Identify normal range of movement for all synovial joints
- Describe and demonstrate measurement of joint range of motion of specified joints (knee, hip, elbow, wrist)

8. Demonstrate and apply knowledge and skills related to the application of assistive devices for ambulation.

Potential Elements of the Performance:

- Identify and describe normal and abnormal gait patterns
- Assess parameters of gait (step length, stride length, width of base of support)
- Describe basic gait patterns using assistive devices

V. EVALUATION PROCESS/GRADING SYSTEM:

- 1. A combination of tests and assignments will be used to evaluate student achievement of the course objectives. A description of the evaluation methods follows and will be discussed by the teacher within the first two weeks of class.
- 2. All tests/exams are the property of Sault College.
- Students missing any of the tests or exams because of illness or other serious reason must notify the professor <u>BEFORE</u> the test or exam. The professor reserves the right to request documents to support the student's request.
- 4. Those students who have notified the professor of their absence that day will be eligible to arrange an opportunity as soon as possible to write the test or exam at another time. Those students who <u>DO NOT NOTIFY</u> the professor will receive a zero for that test or exam.
- 5. For assignments to be handed in, the policies of the program will be followed. For assignments not handed in by the due date, the mark received will be zero. Extensions will be granted if requested in writing at least 24 hours before the due date. There will be a deduction of one percent per day for every school day late with the permission of an extension. This means that if you requested an extension for 5 school days (1 week), 5 percentage points will be deducted from the final grade.
- 6. A supplemental exam may be written by students who meet the following criteria. The student must achieve at least a grade of 55% in the course. The student must have attended at least 80% of the classes. The supplemental exam will then cover the entire course and will be worth 100% of the student's final mark.
