I. COURSE DESCRIPTION:

Students will be introduced to Operating Systems including Microsoft Windows 9X, DOS, and Linux / Unix. Additional topics to be covered include: Word Processing, Internet, and e-mail.

Using Microsoft Windows 9x, you will explore and become familiar with the: Desktop, Start Menu, Status Bar, Task Bar, Icons, Sub-Menus, Find, Recycle-Bin, My Computer, Windows Explorer, and Keyboard Shortcuts.

The DOS section of this course will have you implement more than 20 internal and external commands. In addition, you will be introduced to OS concepts such as: boot process, mbr, fat, fat16, fat32, long filenames, ascii, bits, bytes, cylinders, tracks, sectors, platters, and partitions.

Linux / Unix history will be explored, followed by the implementation of integral command line commands.

- 3. **Produce documents and reports using Microsoft Word** <u>Potential Elements of the Performance</u>:

This learning outcome will constitute approximately 10% of the course.

- Learn the Microsoft Word GUI environment including, title bar, Menu bar, and status bar
- Create documents
- Open, close, save and delete documents
- Identify default file extensions
- Format your documents using bold, italics, underlining, font face, font size, headers, footers
- Use spell check and thesaurus
- Insert graphics
- Compare text Vs .wpd file types
- Apply styling to your documents
- Learn and apply four methods of cut, copy, and paste
- Work with rulers, margins, and tabs
- Apply bullets
- Explore and apply right-mouse click routines
- Control page layouts using various view methods
- Learn and apply print concepts including options and properties

4. **Define and apply Operating Systems theory and concepts** <u>Potential Elements of the Performance</u>:

This learning outcome will constitute approximately 15% of the course.

- Compare various operating systems
- Learn the concepts of kernel, shell, process, program execution, input / output operations, communications, error detection, and memory management
- Explore the details of cylinders, tracks, sectors, platters and partitions
- Explore the boot process of an operating system with relation to computer hardware
- Learn the concepts of bits, bytes, ascii, ebcdic, and binary

5. Apply Internal and External DOS commands <u>Potential Elements of the Performance</u>:

This learning outcome will constitute approximately 30% of the course.

- Compare internal Vs external DOS commands
- Learn the DOS tree structure
- List files by name, extension, date
- Create and remove directories
- Copy / move files and directories
- Hide / protect files and directories
- Apply wildcards
- Load and use the keyboard buffer file
- Create files using a DOS editor
- Create / modify autoexec.bat and config.sys files
- Learn the relevance of io.sys, msdos.sys, and command.com
- Create and work with standard batch files
- Compare "exe", "com", and "bat" files
- Format system and non-system diskettes
- Duplicate diskettes
- Explore the debug utility
- Search for files
- Set system date and time
- Compare "real" Vs "protected Mode"
- Identify the 5 types of memory usage
- Apply memory management in real-mode
- Create an optimized memory managed boot-disk

6. Apply Linux/Unix commands and fundamentals <u>Potential Elements of the Performance</u>:

This learning outcome will constitute approximately 20% of the course.

- Learn the history of Linux / Unix
- Learn about the various versions of Linux / Unix
- Investigate the current trend of Linux
- Use Telnet to login to a Linux server
- Learn multi-tasking and multi-session
- Learn the Linux boot process
- Compare Linux vs. Dos commands
- Create, use, and remove Linux directories
- Use wildcards
- Compare Linux editors
- Create documents using a Linux editor
- Create and modify a ".profile" file
- Work with pipes, filters, and redirection
- Change file / directories attributes
