### I. COURSE DESCRIPTION:

This course continues the studies begun in CSD313 (Java II), with a heavy emphasis on Enterprise Level applications that utilize servlets, java server pages and java beans. The student write introductory level web applications and be able to discuss enterprise level technologies and the issues surrounding their development and deployment.

Upon successful completion of this course, the student will demonstrate the ability to:

1. Write Java Applications demonstrating Java Servlets and java Server Pages

- execute servlets within the Apache Tomcat Server Environment available in Netbeans.
- Write code that responds to http requests.
- Write code that implements session data.
- Write code that accesses a database from a servlet.
- Create and deploy Java Server Pages.
- Create dynamic web pages.
- Manipulate javabeans in a jsp.
- 2. Writing Java Applications demonstrating Java Beans <u>Potential Elements of the Performance</u>:
  - understand how Java Beans enable the creation of component oriented software.
  - Study a Java Bean
  - create a Java Bean
- Modify a Java Application demonstrating Java in the Enterprise Potential Elements of the Performance:
  - understand the role of Java services in an Enterprise application by studying the Enterprise Java Case Study.
  - Understand the following
    - MVC in an Enterprise Java applications
    - how XML and XSLT can generate content for various client types.
    - Multi tier applications
    - The role of presentation logic in a multi tier app.
    - The use of servlets in the middle tier
    - EJB's in an enterprise app.

- Deploying enterprise apps.
- 4. Understand and discuss security issues and write programs demonstrating that understanding.

- understand public/private key infrastructure.
- Understand digital signatures, digital certificates and certification authorities
- learn how java provides solutions to security problems.
- Understand declarative and programmatic security.
