I. COURSE DESCRIPTION:

This course is an extension of the CSD206 Visual Basic introductory course that covered the basics of Visual Basic.NET programming. This course will cover debugging techniques, creating executable files, and distributing a Windows application. The students will then move into designing, creating and using a Class. The students will then be ready to access databases with ADO.NET, structure exception handling and printing. The course will conclude with creating web applications and writing data to a database.

The course focuses on hands-on, so there will be plenty of do-it-yourself features throughout the course.
