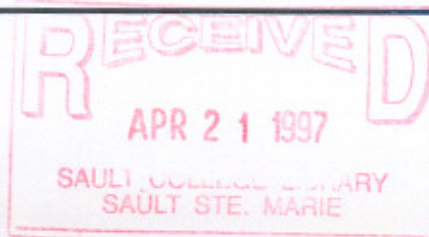

**I. COURSE DESCRIPTION:**

**This course will provide a practical orientation to the legislation governing young persons in conflict with the law. Statutes covered will include the Young Offenders Act, the Ministry of Correctional Services Act, the Child and Family Services Act and the Provincial Offenses Act. Also outlined will be the service delivery systems utilized in the implementation of the above statutes from both a community and custodial perspective. Theories of causation, delinquency, and rehabilitative programs will be explored.**

**II. LEARNING OUTCOMES AND ELEMENTS OF THE PERFORMANCE:**

**B. Learning Outcomes with Elements of Performance:**

Upon successful completion of this course the student will demonstrate the ability to:

1. Define the philosophical and historical basis for statutes affecting young persons in conflict with the law.

- describe the historical response to delinquency and youths
- identify the Canadian historical perspective of young offenders
- explain the development of a separate justice system for young offenders

2. Compare and contrast the philosophies and principles of the Juvenile Delinquents Act and the Young Offenders Act.

**Potential Elements of the Performance:**

- describe and explain the attitudes, beliefs and functions of the Juvenile Delinquents Act (JDA)
- outline and explain the criticisms of the JDA
- list and describe the principles of the Young Offenders Act (YOA)
- contrast and debate the elements and effectiveness of the JDA versus the YOA

3. List and describe the salient sections of legislation pertaining to young offenders in Ontario.

**Potential Elements of the Performance:**

- outline and describe the important sections of the Young Offenders Act
- outline and describe the young offender sections of the Child and Family Services Act
- outline and describe the young offender sections of the Ministry of Correctional Services Act
- outline and describe the young offender sections of the Provincial Offences Act

4. Describe the provincial and local components of the service delivery systems available to young offenders.

**Potential Elements of the Performance:**

- outline and describe the functions and roles of:
    - Indian Friendship Centre
    - Native Police Services
    - Observation and Detention Home
    - Operation Springboard
    - Young Offender Probation Services
    - Sault Ste. Marie Police Services
    - Young Offender Court Services
    - Childrens Aid Society
    - Sault Ste. Marie Jail.
- 5) Record relevant and current issues regarding young persons in conflict with the law and write a report based on these observations.

**Potential Elements of the Performance:**

- collect newsclippings and design a scrapbook that depicts the current trends in delinquency, young offenders and/or the young offender criminal justice system
- complete a research project and make a presentation to the class on one of the following current topics:
  - gender issues
  - cultural/ethnic issues
  - alcohol/drugs
  - domestic violence
  - prostitution
  - youth gangs
  - other topics approved by instructor
- create a five minute video which visually represents the topic of the research presentation

6. List and explain the causal factors of delinquency.

**Potential Elements of the Performance:**

- explain the Strategic Analysis Theory of delinquency
- list and discuss each of the identified goals of delinquency
- demonstrate an understanding of the Normative Behavioural Continuum
- identify and explain the myths and facts of delinquency

7. List and describe current rehabilitation programs for young offenders.

**Potential Elements of the Performance:**

- discuss and evaluate various methods of rehabilitation
- list and explain various programs of rehabilitation

2. Comparison of the Juvenile Delinquents Act and the Young Offenders Act.
3. Legislative statutes affecting young persons.
4. Community based services for young offenders.
5. General issues of delinquency.
6. Profile of a young offender.
7. Rehabilitative programs for young offenders.
8. Current issues impacting on young offenders.
