PHILOSOPHY/GOALS

This course is designed to explore the process which occurs when people become a group. The focus will be on group structure and the "dynamics" of the group. The application of the group in therapeutic process will be examined. Various group techniques and approaches which are pertinent to the experience of a Correctional Worker will be studied.

GOALS AND OBJECTIVES

- 1. To increase self-awareness of the individual within the group context.
- 2. To become aware of the effective use of feedback in the group.
- 3. To demonstrate in verbal, written and behavioural terms, an understanding of group dynamics.
- 4. To develop observational and analytical skills in assessing group functioning.
- 5. To explore and understand the causes for and changes in individual behaviour in groups.
- 6. To recognize the needs of the individual and the group.
- To study group formation, composition and motivation, relative to specific tasks - maintenance functions.
- 8. To develop strategy to meet identified group goals.
