L PHILOSOPHY/GOALS:

In this course, students will be provided with an overview on all aspects relevant to the field of addictions. The class will investigate general information about substances, their effects and the development of dependency. In addition, students will explore the impact of addictions on the individual, their families, and society, as a whole. Finally, the healing processes involved in recovering from an addiction will be examined, including the most common treatment approaches utilised. The students ensure the applicability of course information by examining a variety of addiction resources.

DL LEARNING OUTCOMES AND ELEMENTS OF THE PERFORMANCE:

Upon successful completion of this course the student will demonstrate the ability to:

- 1) Identify the origins and history of drugs and drug-taking behaviours.
- 2) Identify and describe the physiological, psychological and environmental factors that influence the use/abuse of, and effects of, drugs
- 3) Identify and describe the nature and physiological effects of a number of commonly misused and abused licit and illicit drugs.
- 4) List and describe the most commonly used treatment modalities for the treatment of drug and alcohol addictions.
- 5) Identify cultural differences that may be encounter with clients with addictions and identify adaptations that may be made to treatment modalities to be more effective with these clients.
- 6) Identify the most commonly abused drugs and their negative impact from a family, community and societal perspective.

Each group member will be required to equally participate in the development of the report and in presenting the group's materials. Further specifics will be given out by the instructor.
