#### **COURSE DESCRIPTION:**

I.

This second level mathematics course for the pre-health program.

Building on the concepts explored in the first course, the focus is on quadratic, exponential, and logarithmic functions. Also explored is a variety of data analysis techniques.

- 1. Use the laws of exponents to simplify expressions.
- 2. Solve quadratic equations by factoring, using quadratic formula, and graphically.

- 4. Interpret, analyse and summarize data graphically and numerically using in a variety of tools and strategies.
