This Course deals with the broad fundamentals of the Canadian legal system. It is also designed to help the student develop research and analysis skills required to locate, interpret, and apply statutory, regulatory and case law.

- Explain how to cite cases
- Explain how to cite legal books and journals
- Apply proper legal citation
- Locate and Identify various sources of case law

3. **Demonstrate the ability to interpret and apply case law**

Potential Elements of the Performance:

- Explain various parts of case law
- Explain how to read a case
- Apply legal reasoning fundamentals to explain case
- Determine applicability of particular case law to various situations

4. **Understand and discuss the implications of case law**

- Explain judicial precedence
- Explain the common law analogy & distinctions, synthesis & reconsolidation
- Explain how case law changes and evolves statutory and regulatory law

*This learning outcome will constitute approximately 30 % of the course's grade*

5. **Demonstrate knowledge of case law as it affects the legal rights of Canadians**

Potential Elements of the Performance:

- Explain the various sections of the Charter of Rights and Freedoms
- Explain the process of addressing a Charter of Rights Violation within the contexts of said document.
  - Explain various case law that affect the legal rights under the Charter of Rights and Freedoms of Canadians

*This learning outcome will constitute approximately 30 % of the course's grade*
