- I. COURSE DESCRIPTION: This course leads students through an in-depth review of provincial acts and regulations pertaining to natural resources and parks. Students will learn how to locate, interpret and analyze various provincial acts, regulations, and cases.
- II. LEARNING OUTCOMES AND ELEMENTS OF THE PERFORMANCE:

Upon successful completion of this course, the student will demonstrate the ability to:

1. Understand the Provincial Offences Act and its application to governing the enforcement and prosecution of offences created by provincial statute.

#### Potential Elements of the Performance

- Identify the nexus between the Provincial Legislation and the Canadian Charter of Rights and Freedom
- Interpretation and application of the Provincial Offences Act
- Identify the purpose of the various Provincial Offences Forms
- Demonstrate how to issue a Part I ticket, Part I summons, Part III summons, or long form summons.

This learning outcome will constitute approximately 10 % of the course's grade

2. Understand the origin of law and how law is created as it applies to provincial natural resources legislation.

#### Potential Elements of the Performance

- Identify how components of the Canadian Constitution and the Canadian Charter of Rights and Freedom affect inspectors or officer performing their field duties.
- Describe the five categories of natural resources offences and demonstrate the ability to categorize selected sections of various provincial acts or regulations
- Identify the elements of an offence.

This learning outcome will constitute approximately 5 % of the course's grade

Interpret provincial legislation pertaining to fish and wildlife management, specifically the Fish and Wildlife Conservation Act, the Endangered Species Act, the Fish

# **Inspection Act and the Heritage Hunting and Fishing Act.**

- Identify the right to hunt and fish in Ontario
- Interpretation and application of the Fish and Wildlife Conservation Act and the regulations
- Interpretation and application of the Endangered Species Act and the regulations
- Interpretation and application of the Fish Inspection Act

This learning outcome will constitute approximately 25 % of the course's grade

- Interpretation and application of the Trespass to Property Act

This learning outcome will constitute approximately 20 % of the course's grade

Interpret provincial legislation pertaining to forest management, specifically the Crown forest Sustainability Act and the Forest Fire Prevention Act.

- Interpretation and application of the Crown Forest Sustainability Act
- Interpretation and application of the Forest Fire Prevention Act

This learning outcome will constitute approximately 15 % of the course.

6. Interpret provincial legislation pertaining to Ontario parks, specifically the Provincial Parks and Conservation Reserve Act
