Students will develop skills in conducting client consultations and will develop the practical skills required to perform manicure and pedicure procedures, hand and foot massage as well as additional spa treatments. Achieving a perfect regular and French polish application is stressed. Emphasis will be on the practice of safety, sanitation and disinfection of workstations and implemenents. Students will be introduced to the Spa at Sault College where emphasis will be on customer service, retailing of p,roducts and services and the overall development of practical skills.

- c. Use gloves, a mask or other suitable personal protective equipment appropriately during the provision of treatments to ensure safety of the client, yourself and others
- d. Handle hazardous materials and dispose of waste and chemical materials in compliance with Algoma Public Health regulations
- e. Use electrical equipment safely and appropriately
- f. Use manicure and pedicure instruments in a safe, correct and professional manner, considering client health history needs.
- g. Correctly operate and determine maintenance requirements for equipment in compliance with the occupational health and safety legislation regulations and infection prevention and control guidelines
- h. Maintain and store all equipment, instruments, materials and supplies according to manufacturer's guidelines and as required by Algoma Public Health regulations
