Course Description:	This course introduces the Professional Makeup Procedure. Emphasis of instruction will be on perfecting each phase of the procedure in order to gain the professional polish expected by industry professionals as well as clients. Practical instruction will develop artistry skills with Classic, Pin-up, Smokey and Bridal applications and for a variety of age ranges including preteen and mature clients. Basic corrective techniques utilizing colour theory as well as highlighting and contouring techniques for enhancing facial features and eye shapes is emphasized. Students will also receive comprehensive training with eyebrow shaping and enhancements. Client consultation skills will be developed. Sanitation and disinfection of all tools, and supplies will be discussed and practiced in order to ensure the health and safety of yourself and others.
