## I. COURSE DESCRIPTION:

This course builds on the knowledge and skills acquired in the introductory course Nail Care Techniques 1. This course will reinforce knowledge of the anatomy of the foot and leg. Students will gain skills in client consultations and pedicure procedures. Sanitation and sterilization will be practiced.

## II. LEARNING OUTCOMES AND ELEMENTS OF THE PERFORMANCE:

Upon successful completion of this course, the student will demonstrate the ability to:

1. Describe the basic anatomy of the foot and leg.

Potential Elements of the Performance:
a. Identify and describe the functions of the bones and muscles of the foot and lower leg that are affected by massage.
2. Distinguish between normal and abnormal nail disorders and diseases.

Potential Elements of the Performance:
a. Identify disorders that may be treated in the salon and those that must be treated by a doctor.
b. Practice sterilization and sanitation procedures.
3. Practice safe and effective use of implements.

Potential Elements of the Performance:
a. Identify implements used for a pedicure.
b. Describe what each implement is used for.
c. Identify implements that are reusable and must be sterilized.
d. Identify implements that are disposable.
e. Follow step-by-step procedures on the use of each implement.
f. Follow sterilization and sanitation procedures.
4. Prepare a pedicure station for a pedicure service.

## Potential Elements of the Performance:

a. Identify all implements; nail cosmetics and materials needed to perform a pedicure.
b. Follow step-by-step procedure for pedicure station set up.
c. Maintain a safe and sanitary work area.
d. Practice all sanitation and sterilization procedures.
5. Perform a professional client consultation.

## Potential Elements of the Performance:

a. Display professional conduct.
b. Display effective communication skills.
c. Record client information on a client health/record form.
d. Determine when it is necessary to take precautions.
e. Identify contraindications.
f. Determine when it is necessary to refer a client to a doctor.
g. Recommend products and add on services.
h. Perform a post service and record information of service and recommendations.
6. Perform a pedicure.

Potential Elements of the Performance:
a. Perform a pedicure preservice.
b. Conduct a client consultation.
c. Follow step-by-step pedicure procedure.
d. Perform a foot massage.
e. Practice sanitation and sterilization of all equipment and implements.
7. Demonstrate the correct technique for polish application

Potential Elements of the Performance:
a. Follow step-by-step procedures.
8. Perform a foot massage.

Potential Elements of the Performance:
a. Describe the benefits of a foot massage.
b. Identify conditions where precautions must be taken.
c. Follow step-by-step procedures.
9. Perform a paraffin wax treatment on the feet.

Potential Elements of the Performance:
a. Describe the benefits of a paraffin wax treatment.
b. Identify contraindications.
c. Follow step-by-step procedure.
d. Follow safe and sanitary requirements.
10. Show an understanding of how bacteria and infections can breed in the Salon.

## Potential Elements of the Performance:

a. Identify the steps necessary to protect self and clients from the spread of infection
11. Identify skin disorders that can and cannot be serviced in a salon.

## Potential Elements of the Performance:

a. Identify and describe the characteristics of skin disorders that can and those that cannot be serviced.
12. Show and understanding of how aromatherapy can be incorporated into a nail service.

Potential Elements of the Performance:
a. Explain where essential oils come from and some of their benefits.
b. Identify carrier oils and understand their use.
