- List safety issues associated with abrasions and scalp disorders
- Identify desired curl formation
- Perform strand test to determine best product and timing per analysis
- Prepare client for service (draping, hair preparation)

- Identify and apply various end paper wraps used to secure ends
- Demonstrate multiple design wrap patterns during the physical application of permanent waving (brick-lay, directional, spiral)
 - Demonstrate varying base controls using application tools

Course Outcome 6.

Perform procedural steps to complete permanent wave service.

Learning Objectives 6.

- Locate and follow manufacturers specifications
- Demonstrate pre-service treatments for hair preparation
- Select tools for service
- Section hair for design wrap and control
- Demonstrate hand and tool manipulation techniques
- Apply protective cream
- Apply selected product and time
- Visually inspect hair during processing with test curl
- Demonstrate removal of waving solution providing support to neck (rinsing, water temperature and dry toweling)
 - Demonstrate blotting and air neutralizing
 - Apply neutralizing product
 - Demonstrate the removal of neutralizer and apply finishing product according to manufacturer's specifications.
