I. COURSE DESCRIPTION:

This course is an introductory level drawing and illustration course that requires students to develop drawing skills using traditional media. The course is intended to provide the student with experience and practice in developing the basic understanding of perspective, tonal range and the development of conceptual ideas.

II. LEARNING OUTCOMES AND ELEMENTS OF THE PERFORMANCE:

Upon successful completion of this course, the student will demonstrate the ability to:

1. <u>Demonstrate the ability to accurately use drawing systems.</u>

Potential Elements of the Performance:

Demonstrate the ability to use principles of one and two point perspective to create accurate drawings

Understand the elements that create perspective

Demonstrate the ability to produce plan/orthographic views of object and environment concepts

2. Demonstrate the ability to accurately draw from observation.

Potential Elements of the Performance:

Practice the ability to draw from observation using the rules of perspective Practice the ability to render observed textures

Develop and understanding of proportions within an environment or object

3. <u>Demonstrate understanding of light direction and tonal range.</u>

Potential Elements of the Performance:

Develop an understanding of light source and light direction to achieve accurate shape and form of objects and environments.

Demonstrate the ability to use appropriate tonal range using proper highlights, midtones, shadows and cast shadows.

4. <u>Demonstrate the ability to utilize illustration tools safety and</u> effectively

Potential Elements of the Performance:

Demonstrate an understanding of the use of media such as graphite, pen and ink, markers and pencil crayons.

Develop safe and proper use of tools such and cutting knifes on appropriate substrates.

5. Maintain a sketchbook

Potential Elements of the Performance:

Use the sketchbook as an invaluable tool to develop drawing skills.

Keep record of thoughts and ideas for concepts, projects, etc. in the sketchbook.

Create a reference library of images ranging from vehicles, buildings, landscape, characters, accessories, etc. that can be used to assist with projects.

Use material and references in a creative manner to assist with projects.

6. Demonstrate an ability to present artwork in a professional manner Potential Elements of the Performance:

Demonstrate an ability to use appropriate cutting knives and measurement tools on appropriate substrates safely

Demonstrate the ability to care for, present, and mount finished illustrative work in a clean, accurate and professional manner according to instruction.

VI. SPECIAL NOTES:

Attendance:

Sault College is committed to student success. There is a direct correlation between academic performance and class attendance; therefore, for the benefit of all its constituents, all students are encouraged to attend all of their scheduled learning and evaluation sessions. A total absence of 3 classes for the semester will be tolerated. After 3 absences penalties will take effect, an additional 10% will be deducted from the final grade for this course per class missed

DEDUCTIONS – LATES, EXTENSIONS AND FAILS

Lates:

An assignment is considered late if it is not submitted at the time and date specified by the instructor. A late assignment will receive a 10% deduction and must be submitted within one week of the initial due date. Maximum grade for a late assignment is "C"

Extensions:

The instructor may grant extensions for assignment/projects under exceptional circumstances (e.g. death in the family or serious illness). An extension, when offered, will have a mutually agreed upon deadline that does not extend beyond the conclusion of the current semester.

Fail:

A fail grade (F) is assessed to an assignment that has not been executed to a minimum satisfactory "D" grade level or in which the directions have not been followed correctly.

A failed assignment must be entirely re-done or corrected according to the instructor's specific instructions and resubmitted within one week.

Maximum grade for a failed assignment is "C"

Preliminary Studies:

All assignments require preliminary or intermediate steps such as research, reference, thumbnails and roughs.

These intermediate steps are evaluated according to criteria established by the instructor and submitted according to established timelines. The final grade for each assignment will be an average of the grade achieved for all stages of the assignment. This reinforces the importance of the preliminary development of each concept.

Resubmission policy

- Any assignment completed during this course may be submitted for re-evaluation if the student meets the following criteria.
- an assignment that was initially submitted past the initial assigned deadline will not be eligible for re-evaluation.
- an assignment that initially achieved a fail grade must be resubmitted to achieve minimum project standards and will receive a maximum C grade as indicated under the section for Lates and Fails in this outline.
- the resubmitted project must be accompanied by the original project and the original evaluation sheets (with written indication of grade breakdown) provided by the professor
- assignments may be resubmitted at any time during the semester. The final date for last resubmissions will be announced by the professor during class and usually are no later than two weeks prior to the end of the semester.
- Resubmitted assignments must identify the project and class, and be clearly marked "RESUBMISSION" when submitted
- it must be understood that resubmitted assignments are usually marked with greater scrutiny than first submissions to take into consideration the learning experiences, practice, and achievement of learning outcomes achieved by the student during later sessions in the semester.
- When comparing the original submission grade and the resubmission grade the student will receive benefit of the higher grade

Assignments will not be accepted for resubmission to include preliminary studies.
 Preliminary studies should be completed before the commencement of work on final
 comprehensives and as such will only be considered for evaluation on or before the
 original submission. Assignments resubmitted to include preliminaries must be
 completely re-done and have a new creative direction for evaluation.
