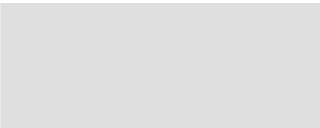

Course Description:	This course focuses on authentic and practical work experience in the sport industry. Students will acquire practicum placements in SPT300 that introduce them to some of the many types of work done in the field of sports administration, in a variety of settings. During the practicum, students work closely with the placement coordinator and either mentors in the College Athletics department or in community sport organizations who will mentor the students through sport-related administrative tasks in a real-world environment. The placement will include a minimum of 35 hours.
