I. COURSE DESCRIPTION:

The subject is a study of the principles of learning and techniques of instruction and a review of theory of flight and general aviation knowledge, leading to the Department of Transport Flight Instructor Endorsement Examinations. In addition, students will participate in classroom exercises to gain experience in giving preparatory instruction and pre/post flight briefings.

II. LEARNING OUTCOMES AND ELEMENTS OF THE PERFORMANCE:

Upon successful completion of this course the student will demonstrate the ability to:

- demonstrate sufficient knowledge of the requirements toward the DOT written exam for the Flight Instructor Rating, Class IV as per the Study and Reference Guide, TP2810E.
- 2) meet the practical requirements of conducting Preparatory Instruction, Pre-flight and Post-flight briefings, and student evaluation as per the DOT Flight Test Guide - Flight Instructor Rating.
- 3) be recommended to write the DOT Class IV Flight Instructor Written Exam. (pending meeting the experience requirements)

V. EVALUATION PROCESS/GRADING SYSTEM

The Student will be assessed in four (4) ways as follows:

- 1. The student will be expected to prepare and hand in a lesson plan on an assigned air exercise. This lesson plan will be marked for completeness and conformity to the recommended lesson plan layout. This will be worth 10% of the overall mark.
- 2. The student will be expected to give a lesson on the assigned air exercise under a simulated circumstance. ie: Preparatory instruction to one or more students within the class. This lesson will be marked by the other students as per the Flight Test Guide. This will be worth 10% of the overall mark.
- 3. The student will be expected to mark each other student in the class who is giving an assigned lesson. The marking sheet will be assessed by the instructor for conformity to the Flight Test Guide. This will be worth 10% of the overall mark.
- 4. The student will be expected to write a Final Written Examination which will be similar in layout and content to the Exam Specified in the Study and Reference Guide. This exam will be worth 70% of the overall mark.

The Four marks obtained will be added together for a total mark out of 100.
