NATURE OF COURSE AND OBJECTIVES: This course is designed to build upon the student's knowledge of theory and technique in Child Care Work. Three major therapeutic approaches will be examined with emphasis upon application in real-life treatment situations from the student's experiences. Variables affecting treatment implementation will be identified. The major emphasis will be on an empathic view of the youngster, the family and the Child Care Worker as a professional agent of change.

The course will include an in-depth study of child abuse, with emphasis on the treatment of the abused child.

A major goal is to develop in the student an ability to incorporate theory in the design and application of treatment programmes with young people. An ability to research materials to support programme ideas will be expected. The case study method will be employed.

At all times students will be expected to apply the skills learned in interpersonal relations, group process, psychological and child care work theory, as befits the "senior-level" nature of this course.

### REQUIREMENTS:

a) Case analysis and treatment planning are main focili of this course. There will be <u>three</u> take home cases that will require a clearly written (or typed) analysis and treatment plan. At least one of these will involve a written a) critique from a classmate. One will be a group project (groups of 2 or 3 members).

A one-week advance notice will be provided in each case.

More details will be provided in class.

Length of each report - approx. 800-1000 words.

References are expected, and reporting style must be according to APA format.

b) Journal article presentation (oral, in class) - a <u>summary</u> of a recent (within 2 years) article from a psychological, counseling or child care work journal, the topic of which must be in the area of child, adolescent or family development, pathology or treatment. Length: about 15-20 minutes, including discussion (for which the presenter is responsible).

Grading: 5 marks for accuracy and clarity summary
5 for style of presentation and discussion.

c) One <u>written summary</u> of a journal article as per above - it <u>must</u> be of an article that was <u>not</u> covered by <u>any</u> oral presentation!

Length - 1-2 pages, consisting of 1-2 paragraphs describing the article and the rest being your reaction to the article.

Due Date: November 4, 1981.

- d) Final Examination: December 16, 1981
- e) Participation: including punctuality, attendance, attentiveness, committment, professionalism and involvement.
